printed on their ballots, "for change of boundary lines of Chippewa county in favor of Swift county," (and those opposed to said change,) "against change of boundary lines of Chippewa county," and returns thereof shall be made to the same officer by the judges of election of the several townships, and by the auditor of said Chippewa county as votes for state officers.

SEC. 3. The county seat of said county of Swift is hereby established at Benson, on the south-west quarter where county ment located. of section number five, township number one hundred and twenty-one north, of range number thirty-nine, west of the fifth principal meridian.

SEC. 4. The county of Swift is hereby attached for Attached to Pope judicial purposes to the county of Pope.

The foregoing provisions of this act shall take when not to take SEC. 5. effect and be in force from and after the ratification and effect. adoption of the proposed change by a majority of the voters of Chippewa county.

SEC. 6. All acts and parts of acts inconsistent with Repeat of Inconthis act are hereby repealed.

SECTION 1. The counties of Kandiyohi and Monongalia are hereby consolidated in one county with the name of Kandiyohi.

SEC. 2. The county seat of said county of Kandiyohi is hereby temporarily located at Kandiyohi station, on the southeast quarter of the northwest quarter of section ten, town one hundred and nineteen north, range thirty four west.

SEC. 3. The said county of Kandiyohi shall assume all debts and liabilities of said counties of Kandiyohi and
