CHAPTER CXIX.

An Act to amend Section Eleven, of Chapter Twenty-Four, of the Special Laws of one thousand eight hundred and sixty-nine, relating to the appointment of a Board of Construction to aid in the preservation of the Falls of Saint Anthony.

Feb'y 16, 1870.

SECTION 1. Amendment to Section Eleven (11) of Chapter Twenty-Four (24) of the Special Laws of 1869. Authorizing a change in the Board of Construction.

2. When act to take effect.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That section eleven, of an act of the Legislature of the state of Minnesota, entitled "an act to authorize the cities of Minneapolis and Saint Anthony to issue bonds and to appropriate the same to aid in the preservation of the Falls of Saint Anthony, in the Mississippi River," approved March fourth, one thousand eight hundred and sixty-nine, be and the same is hereby amended by adding thereto the following proviso: *Provided, That* the city council of the city of Saint Anthony, may at any time, by resolution, remove the member of said board of construction, appointed by such council, and may thereupon appoint another person as member of said board, in the stead of the person so removed; and the Saint Anthony Falls Water Power Company may also, at any time

appoint any other person as member of said board, on its part, in the stead its agent.

When act to take effect.

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER CXX.

An Act to amend Chapter One Hundred and Eighteen, of the Special Laws of one thousand eight hundred and sixty-eight, entitled "An act granting certain persons the right to manufacture and sell gas in the City of Rochester.

SECTION 1. Provisions of former act confirmed.

2. Amendment to Section One (1) of Chapter One Hundred and Eighteen (118) of the Special Laws of 1868. Change of name of incorporator.
3. Amendment to Section Three (3) of said act. When to meet for organisation.
4. When act to take effect.

Be it enacted by the Legislature of the State of Minnesota:

Provisions of former act confirmed.

SECTION 1. That all and singular the provisions of chapter one hundred and eighteen, of the special laws of one thousand eight hundred and sixty-eight, entitled "An act granting certain persons the right to manufacture and sell gas in the city of Rochester," approved March fifth, one thousand eight hundred and sixty-eight, be and the same are continued in full force and the same are confirmed to said corporation, its successors and assigns in all respects, except only in so far as the same is modified, amended or changed by the provisions of this act.

Change of name of incorporator.

SEC. 2. That section one of said act be amended by substituting the name of A. K. Williams for the name of A. R. Williams, now appearing in the printed copy thereof.
