by the constitution, by-laws, rules and regulations of said society. *Provided*, Such constitution, by-laws, rules and regulations be not contrary to any of the laws of this state or of the United States; and provided further, That the rights which have accrued, and the liabilities which have been incurred under the said act of incorporation shall not be affected by the provisions of this act.

SEC. 2. Said society is an institution of learning, and an institution for mental and bodily development and improvement, and all property belonging to said society and used by it for the purposes for which it is created, such as buildings, apparatus, and is and shall be free from taxation.

CHAPTER CXXV.

Feb'y 28, 1870.

An Act amendatory to an act entitled an act to incorporate the German Reading Society of St. Cloud, approved February twenty-seventh, one thousand eight hundred and fifty-five.

SECTION 1. Amendment to the act incorporating the German Reading Society of St. Cloud, Special Laws of 1855. Change of name of mid Society-property exempt from taxation.

2. When act to take effect.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. The title of the German Reading Society of St. Cloud is hereby changed, and shall be hereafter known as the St. Cloud German Reading and Library Society, and the library and building of the same are hereby exempt from taxation to the amount limited by their charter.

SEC. 2. This act shall take effect and be in force from when act togate and after its passage.

An Act to amend an act relating to change of names of certain towns in Douglas County.

SECTION 1. Amendment to Chapter Eighty-Two (S2) of the Special Laws of 1869.

3. Change of name of Maple Lake to that of Hudson Lake.

4. The town of Atkinsville changed to that of Mos.

5. When act to take effect,

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That chapter eighty-two, of special laws of one thousand eight hundred and sixty-nine, approved Amendment to former chapter. March fifth, one thousand eight hundred and sixty-nine, be and the same is hereby amended so as to read as follows:

Sec. 2. That the town of Roslyn, in Douglas county, Town of Reslyn shall hereafter be designated and known as the town of changed to that Hudson.

Sec. 3. That the body of water known as Maple Lake, in Douglas county, shall hereafter be designated and Lake changed to hudson Lake.

Sec. 4. That the town of Atkinsville, in Douglas Town of Atkinscounty, shall hereafter be designated and known as the ville changed to town of Moe.

SEC. 2. This act shall take effect and be in force from when act to take and after its passage.
