

CHAPTER CLII.

*An Act to locate, survey and establish a State Road from
Beaver Falls, in Renville County, to Wilmar, in Kan-
diyohi County.*

Feb'y 2, 1870.

- SECTION 1. Commissioners appointed to locate, survey and establish said road.
2. Where and when to meet—vacancy, how filled.
 3. May employ surveyor, &c.—compensation.
 4. How expenses of locating said road to be defrayed.
 5. Surveyor to file plat of road.
 6. When act to take effect.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That Horton W. Nelson, Nelson C. Frazier and Noah W. White, are hereby appointed commissioners to locate, survey and establish a state road from Beaver Falls, in Renville county, to Wilmar, in Kandiyohi county.

Commissioners
appointed to lo-
cate a state road.

SEC. 2. The commissioners shall meet in Beaver Falls on any day subsequent to the passage of this act that may be agreed on by them or a majority of them, and proceed to discharge their duties under this act; and if any of said commissioners appointed under this act, shall be unable from any cause to perform the duties imposed by this act, he shall have power to appoint a substitute, who shall have the same authority when so appointed as one of the commissioners named in this act.

Where and when
to meet—vacan-
cy, how filled.

SEC. 3. Said commissioners are hereby authorized to employ in locating said road, two chainmen, one axman, one team and driver, and one surveyor; *Provided*, Said commissioners, chainmen, axman and teamster, shall not receive more than two dollars and fifty cents per day, nor the surveyor more than four dollars per day, for services rendered by virtue of this act.

How expense of locating road to be defrayed.

SEC. 4. The expense of locating said road shall be paid by the counties through or in which said road may pass, in proportion to the distance it may run in each county.

Surveyor to file plat of road.

SEC. 5. At each end, and at every angle of the line of said road, a good and substantial stake shall be set, and a profile of said road shall be made by the surveyor, and shall be filed in the office of the register of deeds of each county through and in which the said road shall pass, on or before the first day of September next. And the said profile of said road or of any part of said road with the proper notes as to courses and distances attached, shall be prima facie evidence of the correctness of the same and of the legal existence of so much of said road as the said profile represents.

When act to take effect.

SEC. 6. This act shall take effect and be in force from and after its passage.

CHAPTER CLIII.

March 7, 1870.

An Act to establish a State Road from Princeton, in Mills Lacs County, to a point between the towns of Monticello and Clear Water, in Wright County.
