

## CHAPTER XXIX.

*An Act to attach the Town of Clinton Falls to the Town of Medford.*March 7, 1870.

- SECTION 1. Clinton Falls attached to the town of Medford—for what purpose.
2. Repeal of conflicting portions of township organization of said town—persons elected to continue in office until expiration of term.
  3. Not to affect any acts done, any action commenced, any debts contracted by either town prior to consolidation.
  4. Repeal of inconsistent acts.
  5. To be submitted to the legal voters of said towns.
  6. When act to take effect.

*Be it enacted by the Legislature of the State of Minnesota :*

SECTION 1. That the town of Clinton Falls, in the county of Steele, and state of Minnesota, be and the same is hereby attached to and made a part of the town of Medford in said county, so that the said town of Medford shall include and be composed of all of the territory embraced in township number one hundred and eight north, range number twenty west.

Attached to town of Medford—for what purpose.

SEC. 2. That the town organization of said town of Clinton Falls, so far as the same may conflict or be inconsistent with the provisions of this act, is hereby dissolved. *Provided*, That any person holding any office in said town under and by virtue of said organization, shall continue to hold such office, and to exercise the rights and powers and to discharge the duties thereof until the expiration of the time for which such officer was elected or appointed, in the same manner and to the same extent as if this act had not been passed.

Conflicting portions of organization repealed—officers to hold until expiration of term.

SEC. 3. Nothing in this act contained shall be so construed as to affect any acts done, or any rights accruing, accrued or established, or any action or proceeding had or commenced in a cause either civil or criminal, or any debts or liabilities contracted by either of said towns, prior to the passage of this act.

Not to affect any acts done prior to consolidation.

Repeal of inconsistent acts.

SEC. 4. All acts and parts of acts inconsistent with this act are hereby repealed.

To be submitted to legal voters.

SEC. 5. For the purpose of carrying out the provisions of this act, the question of attaching the town of Clinton Falls to the town of Medford, shall be submitted to the legal voters of each of the towns of Clinton Falls and Medford, for approval or rejection, at the spring election, to be held on the first Tuesday of April, one thousand eight hundred and seventy, and if a majority of the legal voters, present and voting at such election in each of said towns, shall vote in favor of attaching the town of Clinton Falls to the town of Medford, then and in that case the town of Clinton Falls shall be attached to the town of Medford, according to the provisions of this act.

When act to take effect.

SEC. 6. This act shall take effect and be in force from and after its passage.

## CHAPTER XXX.

March 5, 1870.

*An Act to sever a portion of the territory now comprising the City of Hastings, in the County of Dakota, Minnesota, and annex the same to the town of Nininger, in said County.*

SECTION 1. Description of territory to be annexed to the town of Nininger—to be submitted to the legal voters—election, how conducted—ballots, how prepared—returns to be made to Secretary of State—when act to take effect.

*Be it enacted by the Legislature of the State of Minnesota:*

Territory annexed to town of Nininger.

SECTION 1. That all that portion of the city of Hastings, in the county of Dakota, Minnesota, laying west of a line drawn as follows: Commencing on the Mississippi river where the east line of section seventeen, in township one hundred and fifteen, of range seventeen west, inter-
