When village corporation to cease—who liable for debts of said village. in any village or borough corporation, such village or borough corporation shall upon the establishment of such city corporation, cease, and such city corporation shall thereupon succeed to and become vested with and owners of all the property, real, personal and mixed, which belonged to or was owned by such village or borough corporation at the time when the same ceased to exist, and such city corporation shall also thereupon become and be liable and responsible for all the debts, obligations and liabilities then existing against such village or borough corporation, for any cause or consideration whatever in the same manner and to the same extent as if such debts, obligations or liabilities had been originally contracted or incurred by such city corporation.

An Act to amend Section four, of Chapter twenty-nine, of the General Statutes, of this State, relating to Town Plats.
