SECTION 1. The board of county commissioners of the county of Brown, is hereby authorized to issue bonds Authorized to is for the purpose of liquidating and funding the indebted- sue bonds-for ness of said county, in such denominations as the said "hat purpose. county board may determine, the total sum of bonds to be issued not to exceed the sum of ten thousand dollars.

SEC. 2. Such bonds may bear interest at a rate not to What rate of Inexceed seven per cent. per annum, payable annually, and terest. the principle payable at such time or times as the county board of said county shall determine.

SEC. 3. The proper authorites of said county shall annually include in the general tax, an amount sufficient Principal and into pay the interest on such bonds as may be issued, and terest, how paid. when the principal or any part thereof is about to become due, a sufficient amount to pay such principal.

SEC. 4. The bonds issued under the provisions of this act, shall be signed by the chairman of the board of dyned-daty of county commissioners of said county, and countersigned County Auditor. by the auditor of the county, before they shall be of any

SECTION 1. Authorized to transcribe records from Brown county.

9. When act to take effect.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the registers of deeds of the counties Cottonwood and Redwood are hereby authorized to copy from the records of the county of Brown all entries contained in the said records and relating to real estate in certain towns heretofore included in the boundaries of the said county of Brown. Such records to have the same force and effect as if they had been originally entered upon the records of said counties.

SEC. 2. This act shall take effect and be in force from and after the adoption of the proposed change of the boundary lines between the counties of Brown, Cottonwood and Redwood, to be submitted to the voters of the said counties at the next general election.
