In the county of Waseca on the second Tuesday in February and the third Tuesday in October. Terms of court in Waseca county.

In the county of Dodge on the first Monday in March and first Tuesday in October. Dodge county.

In the county of Rice on the first Tuesday in May, and the second Tuesday after the first Monday in November. Rice county.

In the county of Steele on the first Tuesday in June, and first Tuesday in December. Steele county.

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER LXXVIII.

AN ACT TO AMEND SECTION ONE OF CHAPTER FORTY-SEVEN OF THE GENERAL LAWS OF EIGHTEEN HUNDRED AND SEVENTY-TWO, PROVIDING FOR A TERM OF THE DISTRICT COURT IN CROW WING COUNTY.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. Section one of chapter forty seven of the general laws of eighteen hundred and seventy-two, be and the same is hereby amended so as to read as follows :

That the general terms of the district court in the seventh judicial district shall be held in the several counties in said district at the times hereinafter described, to-wit :

In the county of Sherburne on the second Tuesday of February in each year. Terms of court in Sherburne county.

In the county of Stearns on the second Tuesday of June and the first Tuesday of December in each year. Stearns county.

In the county of Douglas on the first Tuesday of October in each year. Douglas county.

In the county of Pope on the second Tuesday of October in each year. Pope county.

In the county of Morrison on the third Tuesday of October in each year. Morrison county.

- Crow Wing county. In the county of Crow Wing on the fourth Tuesday of April and the fourth Tuesday of October in each year.
- Otter Tail county. In the county of Otter Tail on the third Tuesday of November in each year.
- Becker county. In the county of Becker on the second Tuesday of November in each year.
- Benton county. In the county of Benton on the last Tuesday of November in each year.
- St. Louis county. In the county of St. Louis on the second Tuesday of August and the third Tuesday of February in each year.
- Mille Lac county. And in the county of Mille Lacs on the last Tuesday of September in each year.
- SEC. 2. All acts and parts of acts inconsistent with this act are hereby repealed.
- SEC. 3. This act shall take effect and be in force from and after its passage.

CHAPTER LXXIX.

AN ACT CHANGING AND PRESCRIBING THE TIMES OF HOLDING GENERAL TERMS OF COURT IN THE SEVERAL COUNTIES HEREINAFTER NAMED IN THE NINTH JUDICIAL DISTRICT.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the general terms of the district court in the ninth judicial district shall be held in the several counties in said district at the times hereinafter prescribed, to-wit:

- Terms of court in Nicollet county. In the county of Nicollet on the fourth Tuesday in May, and on the second Tuesday in December in each year.
- Brown county. In the county of Brown on the first Tuesday in May, and on the third Tuesday in November in each year.
- Redwood county. In the county of Redwood, on the second Tuesday in September in each year.
- Renville county. In the county of Renville, on the third Tuesday in September in each year.
