

NUMBER IV.

A JOINT RESOLUTION TO CONGRESS OF THE LEGISLATURE OF THE STATE OF MINNESOTA, ASKING FOR THE ESTABLISHMENT OF A POST ROUTE FROM THE WINONA AND SAINT PETER RAILROAD TO LAKE SHETEK, MINNESOTA.

WHEREAS, The rapidly increasing population of Murray county labor under great inconvenience by reason of the circuitous route by which their postal matter is conveyed, and

WHEREAS, A reliable method of transportation is now furnished to the vicinity of said population by the completion of the Winona and Saint Peter railroad; therefore

Be it resolved by the Legislature of the State of Minnesota:

That congress be requested to pass an act establishing a post route from a point or station on said railroad, on or near section numbered twenty-three, township numbered one hundred and nine, and range numbered forty west, in the county of Lyon, to Lake Shetek post office, in the county of Murray, a distance of about twelve miles.

Resolved, That so soon as said post route may be provided for by law, the honorable postmaster general is requested to place such service thereon as shall accommodate the people of said district.

Resolved, That the governor of this state be requested to forward copies of these resolutions to our senators and representatives in congress, and to the postmaster general.

NUMBER V.

A JOINT RESOLUTION FOR EXTENSION OF TIME FOR APPLICATIONS FOR PENSIONS.

Resolved, By the house of representatives, the senate concurring, That our senators in congress be respectfully requested to use their

influence for the passage in the United State senate of the house bill number five hundred and eleven, which passed the house of representatives in February, one thousand eight hundred and seventy-two, extending the time for ex-officers and soldiers of volunteers to apply for pensions until January, one thousand eight hundred and seventy-four, and paying such pensions from the date of muster-out or discharge.

NUMBER VI.

A JOINT RESOLUTION ON THE SUBJECT OF IMMIGRATION.

Be it resolved by the Legislature of the State of Minnesota :

That, in view of information received through a special message of his Excellency, Horace Austin, governor of the state of Minnesota, to the senate; and of further information received through the honorable state board of immigration of Minnesota, that a large number of intelligent and wealthy German Mennonites, living in colonies of Russia, intend to emigrate to America; the legislature hereby instructs the officers of the state board of immigration to invite the Mennonites to settle within the limits of the state of Minnesota, and to assure them that they will receive a hearty welcome by the people of Minnesota, and that the legislature will endeavor to secure to them the largest religious and political privileges allowed under the constitution of the United States and the constitution of the state of Minnesota; and to render them all reasonable aid and protection during their transit from Russia to the state of Minnesota. The state board of immigration is hereby instructed to transmit copies of this resolution to the officers and agents of the Russian Mennonites.
