provisions of this act, giving dates, numbers, and amounts, to whom

issued and when payable.

SEC. 4. Said board of supervisors shall, and are hereby authorized and empowered to levy an annual tax on all the taxable property of said town, within the limits bounded and described in section three of an act entitled, "An act granting certain powers to the supervisors of the town of Anoka, approved February 29, 1872, in addition to all the other taxes required by law to be levied, sufficient to pay the interest on said bonds as it matures, and also, to levy an additional tax sufficient to pay the principal of said bonds, at the time or times when the same shall become due and payable, which taxes shall be levied and collected in the same manner as other taxes for town purposes are levied and collected.

SEC. 5. Before it shall be lawful for said supervisors to issue such bonds the proposition to issue the same shall be submitted to the legal voters of said town for their approval or rejection, at any annual or special election of said town, due notice as provided by law in other elections, and stating the proposition to be acted upon, The ballots used at such election shall have written or being given. printed thereon the words, "For the issue of bonds for fire apparatus," or the words, "Against the issue of bonds for fire apparatus," and said ballots shall be cast at said meeting in the same manner and canvassed by the same officers as votes cast at annual town elections are cast and canvassed; and if it shall be found, upon such canvass, that a majority of the voters present and voting at such election have voted in favor of such proposition, then the issue of said bonds so issued shall be lawful, and said bonds so issued shall be lawful to all intents and purposes.

SEC. 6. This act shall take effect and be in force from and after

its passage.

CHAPTER CLXXX.

AN ACT TO AUTHORIZE THE CITY OF STILLWATER TO ISSUE ITS BONDS FOR THE ERECTION OF AN ENGINE HOUSE AND CITY HALL.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. The city council of the city of Stillwater, in the state

of Minnesota, are hereby authorized and empowered to issue the bonds of said city to an amount not exceeding twenty thousand dollars, bearing interest at a rate not exceeding ten (10) per cent. per annum, and to be payable twenty (20) years from the date of issue, which bonds shall be styled Stillwater City Building Bonds, and shall be for the sole purpose of raising money to be expended in the purchase of necessary site for, and in the erection of an engine house and city hall for the use of said city of Stillwater.

SEC. 2. The bonds issued under and by virtue of this act, shall be signed by the mayor of said city, and countersigned by the recorder, under the corporate seal of said city, and shall be in sums of not less than one hundred dollars each, with interest coupons attached, such interest to be payable semi-annually, at such place as the city council

may designate.

SEC. 3. To secure the punctual payment of the interest and principal of the bonds provided for in this act, the city council of said city shall have power, and it shall be their duty to assess and collect an annual tax upon the real estate and personal property within the limits of said city subject to taxation, sufficient in amount to pay the interest upon said bonds as the same shall become due and payable, and to provide a sinking fund for the payment of the principal, and the faith of said city of Stillwater shall be pledged for the payment of said interest and principal as in said bonds specified.

SEC. 4. All moneys accruing from the collection of the tax mentioned in the preceding section shall be applied to the payment of the principal and interest of the bonds issued under this act, and to no other purpose, until said bonds shall be fully paid.

SEC. 5. This act shall take effect and be in force from and after

its passage.
