Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That section one of chapter forty-seven

CHAPTER XCVII.

SECTION 1. The general terms of the district court in and for the county of Waseca, in the fifth judicial district, fixed in Waseca shall be held on the third Tuesday in March, and the county. third Tuesday in October in each year.

All writs, recognizances and all other proceedings made returnable to the district court of said county, shall be considered and deemed to be returnable feturnable to at the terms of said court as fixed by this act, and all said term. continuances, appeals, motions, notices and all other proceedings, taken or made to or for any term of said court, shall be considered and construed to be made or taken to the terms of said court, as fixed by this act.
