CHAPTER CXII.

AN ACT TO ATTACH CERTAIN TERRITORY TO THE INDEPENDENT SCHOOL DISTRICT OF THE TOWN OF LE SUEUR IN THE COUNTY OF LE SUEUR.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the west half of the northwest quarter of section twelve in town one hundred and eleven north, of range twentyfive west, is hereby detached from school district number four in LeSueur county and attached to and made a part of the independent echool district of the town of LeSueur in said county.

SEC. 2. This act shall take effect and be in force from and after it passage and approval.

CHAPTER CXIII.

AN ACT TO AMEND "AN ACT FOR THE ESTABLISHMENT AND BETTER REGULATION OF THE COMMON SCHOOLS IN THE VILLAGE OF NORTHFIELD, THE SAME BEING DESIGNATED AS DISTRICT NO. THREE, IN RICE COUNTY, APPROVED MARCH THIRD, EIGHTEEN HUNDRED AND SIXTY-FOUR."

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That section No. five of said act shall be amended by adding the following, to-wit: "Also to sell or exchange any of the real or personal property of said district, on a majority vote of the legal voters present and voting at any regular or special meeting of said district.

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER CXIV.

AN ACT TO INCORPORATE A SCHOOL DISTRICT OUT OF CERTAIN TERRIFORY LYING IN THE COUNTIES OF HOUSTON AND WINONA, IN THE STATE OF MINNESOTA.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the south half of sections thirty-one and thirty-two, in township one hundred and five north, of range seven west, in Winona county, and also sections five, six, seven, eight, the west half of nine, the northwest quarter and the northwest quarter of the southwest quarter of section four, all in township one hundred and four north, of range seven west, in Houston county, be and the same hereby is set off, established and incorporated into a special school district, under the common name and style of "Oak Ridge School District," and as such corporation, under the name and style aforesaid, shall forever have and enjoy all the powers, rights and privileges, and be subject to all the duties, of any school district corporation organized under the general laws of the state.

SEC. 2. Said Oak Ridge school district, for all school purposes, shall be a school district corporation of Winona county, and all taxes hereafter levied for school purposes within said district shall be payable to and collected by the treasurer of said Winona county; and all public money that shall be hereafter appropriated to, or shall become due and payable to said Oak Ridge school district, shall be paid over to the treasurer of said Winona county for the the use of said school district.
