

## CHAPTER CXLVIII.

AN ACT TO APPROPRIATE MONEY FOR THE MAINTENANCE  
OF SOLDIERS' ORPHANS IN THIS STATE.

*Be it enacted by the Legislature of the State of Minnesota:*

For maintenance of soldiers' orphans.

SECTION 1. The sum of eighteen thousand dollars (\$18,000), or so much thereof as may be necessary, is hereby appropriated out of any moneys in the treasury, not otherwise appropriated, for the maintenance of the soldiers' orphans of this state.

When act to take effect.

SEC. 2. This act shall take effect and be in force from and after its passage.

## CHAPTER CXLIX.

AN ACT TO APPROPRIATE MONEY TO PAY INDEBTEDNESS  
OF THE FIRST STATE NORMAL SCHOOL.

*Be it enacted by the Legislature of the State of Minnesota:*

Relative to paying indebtedness of.

SECTION 1. There is hereby appropriated out of any money in the state treasury not otherwise appropriated, the sum of four thousand seven hundred and seventy-one dollars, to be expended for paying teachers' salaries, payable on the twentieth day of September, eighteen hundred and seventy-two, and on the twentieth day of October of the same year, wood and current expenses of the first normal school, at Winona; the same to be paid on warrant of the president of the state normal school board, and countersigned by the secretary thereof. Upon the presentation of such warrants to the state auditor, he shall draw warrants on the state treasurer for the amount of the warrant of the president of the normal school board, not exceeding in all the amount hereby appropriated; and the amounts so drawn shall be used in the payment of said indebtedness.

SEC. 2. This act shall take effect and be in force from and after its passage. When act to take effect.

CHAPTER CL.

AN ACT TO APPROPRIATE MONEY FOR THE SUPPORT OF THE STATE NORMAL SCHOOLS.

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. There is hereby appropriated out of any money in the state treasury, not otherwise appropriated, the sum of seven thousand dollars, for the year one thousand eight hundred and seventy-five, and additional to the sum now annually appropriated, for the support of the first state normal school at Winona, the same to be paid on warrants drawn by the president of the state normal school board, and countersigned by the secretary thereof. For first State Normal School.

SEC. 2. There is hereby appropriated out of any money in the state treasury, not otherwise appropriated, the sum of five thousand dollars, for the year one thousand eight hundred and seventy-five, and additional to the sum now annually appropriated, for the support of the state normal school at Mankato, the same to be paid on warrants of the president of the state normal school board, and countersigned by the secretary thereof. For second State Normal School.

SEC. 3. There is hereby appropriated out of any money in the state treasury not otherwise appropriated, the sum of four thousand dollars, for the year one thousand eight hundred and seventy-five, and additional to the sum now annually appropriated, for the support of the state normal school at St. Cloud, the same to be paid on warrants drawn by the president of the state normal school board, and countersigned by the secretary thereof. For third State Normal School.

SEC. 4. Upon presentation of such warrants to the state auditor, he shall forthwith draw warrants on the state treasurer for the amount named in the warrants of said president and secretary, not exceeding the said sums of seven thousand dollars for said normal school at Winona, the sum of five thousand dollars for said normal school at Mankato, and the sum of four thousand dollars for said state normal school at St. Cloud, for the year one thousand eight hundred and seventy-five, and the money drawn upon such warrants shall be ex- How funds drawn, by whom disbursed.
