CHAPTER LX.

AN ACT TO PRESCRIBE THE TIME OF HOLDING GENERAL TERMS OF THE DISTRICT COURT IN THE COUNTIES OF CLAY AND CROW WING.

Be it enacted by the Legislature of the State of Minnesota:

That the general terms of the district court in SECTION 1. and for the eleventh judicial district shall be held in the counties of Clay and Crow Wing at the times hereinafter prescribed, to-wit: In the county of Clay on the third Tuesday of April, and on the first Tuesday after second Monday in November in each year. In the county of Crow Wing on the fourth Tuesday of October in each year.

All writs, recognizances, and all other papers and SEC. 2. proceedings made returnable to the district court of the said several counties shall be considered and deemed to be returnable to the terms of said court, as the same are fixed by this act, and all continuances, appeals, motions, or other proceedings taken or made to or for any term of said court, shall be construed to be made or taken to the terms of said court as fixed by this act.

SEC. 3. All acts or parts of acts inconsistent with this act are hereby repealed.

CHAPTER LXI.

AN ACT TO AMEND SECTION ONE OF CHAPTER EIGHTY (80,) GENERAL LAWS OF 1873, RELATING TO TIME OF HOLDING COURT IN THE TENTH JUDICIAL DISTRICT.

Be it enacted by the Legislature of the State of Minnesota :

SECTION. 1. That section one of chapter eighty of the general laws of 1873, be amended so as to read as follows:

Section 1. The general term of the district court of the tenth judicial district of the state, shall be held annually at the times and places, to-wit: In the county of Freeborn, on the third terms. Tuesday in June and the first Tuesday in December. In the county of Mower, on the third Tuesday in March and the third Tuesday in September. In the county of Fillmore, on the first Tuesday in June and the second Tuesday in November. In the county of Houston, on the first Tuesday in May and the third Tuesday in October.

SEC. 2. All process, writs, bonds, continuances, appeals, notices, recognizances or proceedings issued and made returnable to the terms of said court in Houston county, as fixed by law prior to the passage of this act, shall be taken and construed as made, taken and returnable to the terms of said court in and for said county of Houston, as fixed by this act.

SEC. 3. This act shall take effect and be in force from and When act to take after its passage.
