SEC. 10. All laws inconsistent with this act so far as they apply to Mower county are hereby repealed,

SEC. 11. This act shall take effect and be in force from and after its passage.

## CHAPTER CLXXI.

AN ACT TO PREVENT THE RUNNING AT LARGE OF CATTLE OR OTHER DOMESTIC ANIMALS, IN THE COUNTY OF MOWER, MINNESOTA.

### Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That section two of chapter (CXXIV) one hundred and twenty-four, (General laws of 1875), be and the same is hereby amended so as to read as follows:

Sec. 2. Any person or persons who shall violate or neglect the provisions of the first section of this act, shall be liable for all damages that may ensue in consequence of the trespass of such animal or animals; *Provided*, Nothing herein contained shall apply to the townships of Lansing and Leroy in said county of Mower.

SEC. 2. This act shall take effect and be in force from and after

its passage.

#### CHAPTER CLXXII.

AN ACT TO VACATE A PORTION OF THE PLAT OF AN ADDITION TO THE VILLAGE OF MEDFORD, STEELE COUNTY, MINNESOTA, KNOWN AS THE RAILROAD ADDITION.

# Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That all that portion of the village of Medford in the county of Steele and istate of Minnesota, platted and recorded as the railroad addition to said village, lying north of Oak street, and east of the line of the Chicago, Milwaukee and St. Paul Railroad, including

all lots streets and alleys therein, is hereby vacated, and said plat shall be deemed and taken to apply only to such lands therein described as are not situated within the boundaries mentioned in this act; *Provided*, That all taxes and assessments heretofore levied or assessed upon any lands or town or village lots in said addition, and now remaining unpaid, shall be and remain a lien upon such lands and lots, and the collection thereof shall be enforced in the same manner as though this act had not been passed.

SEC. 2. This act shall take effect and be in force from and after

its passage.

#### CHAPTER CLXXIII.

AN ACT TO VACATE A PORTION OF THE VILLAGE PLAT OF GENEVA,'
COUNTY OF FREEBORN.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. That all lots, streets and alleys in the village of Geneva, situate on the southeast quarter, of the northeast quarter and the east half of the southeast quarter of section seven, the south half of the southwest quarter of the southwest quarter of section eight, government lot two of section seventeen, and government lot one, and the northeast quarter of the northeast quarter of section eighteen, of township one hundred and four, and range twenty, are hereby vacated. *Provided*, That nothing herein contained shall be so construed, as to abate any taxes heretofore levied or assessed upon any village lots or lands within said village, but all such taxes shall be collected and such lands and lots sold in the same manner as though this act had not been passed.

SEC. 2. This act shall be in force and effect from and after its

passage.
