

CHAPTER. VIII.

AN ACT TO INCORPORATE THE VILLAGE OF SHELDON, IN, THE COUNTY OF HOUSTON, AND STATE OF MINNESOTA:

Be it enacted by the Legislature of the State of Minnesota :

SECTION 1. The following described territory in the county of Houston, and state of Minnesota, to-wit: Section thirty-one (31), and the west half of the west half of section thirty-two (32), in the township No. one hundred and three (103) north, of range six (6) west, be and the same is hereby set apart for incorporation as the village of Sheldon.

SEC. 2. That the following named persons are designated as commissioners under the general laws of 1875, providing for the organization of villages in the state of Minnesota, to post notices of the first election and to conduct the same in said village, to-wit: J. B. Williams, A. H. Walker and J. Phelps.

SEC. 3. That upon organization as directed in the general laws aforesaid of this state, the said territory shall constitute the village of Sheldon, and the inhabitants thereof shall thereupon be endowed with all the rights, powers and duties therein prescribed for organizing villages in this state.

SEC. 4. This act shall take effect and be in force from and after its passage.

CHAPTER IX.

AN ACT TO AMEND AN ACT ENTITLED AN ACT TO INCORPORATE THE VILLAGE OF HOUSTON, IN HOUSTON COUNTY, AND STATE OF MINNESOTA.

Be it enacted by the Legislature of the State of Minnesota :

SECTION 1. That the act incorporating the village of Houston, Houston county, and state of Minnesota, approved February 19th, 1874, be so amended as to exclude from the corporate limits of said village, and annex to the town of Houston, the following described lands, viz: The southwest quarter of section thirty-four, town one hundred and four, range six west, the east half of section thirty-three, town one hundred and four, range six west, the northwest quarter of

section thirty-three, town one hundred and four, range six west, all that part of the northeast quarter of the southwest quarter of section thirty-three, town one hundred and four, range six west, lying north of Elm street, in Mons. Anderson's addition to the village of Houston, the northeast quarter of section thirty-two, town one hundred and four, range six (6) west, the northeast quarter of section four, town one hundred and three, range 6 west, the east half of the northwest quarter of section four, town one hundred and three, range six west, and seven (7) acres off the east-side of the northwest quarter of the northwest quarter of section four, town one hundred and three (103), range six west.

SEC. 2. This act shall be in force from and after its passage.

CHAPTER X.

AN ACT TO INCORPORATE THE VILLAGE OF MINNESOTA LAKE.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the following described territory, to-wit: Commencing at the center of section thirty-three (33) in township number one hundred and five (105), north of range twenty-five (25) west, in the county of Blue Earth and state of Minnesota, running thence east, following the quarter section line, to the east line of section number thirty-four (34), thence south following the section line to the county line between the counties of Blue Earth and Faribault, thence east following said county line, to the quarter section post between sections two (2) in township one hundred and four (104), range twenty-five (25) and thirty-five (35), in township one hundred and five in said range, thence south following the quarter section line to the center of section fourteen (14), township number one hundred and four (104) north of range twenty-five (25) west in the county of Faribault, thence west following the quarter section line to the west line of section number sixteen (16), township number one hundred and four (104), north of range twenty-five (25) west, thence north following the section line to the county line between the counties of Blue Earth and Faribault, thence east following the county line to the quarter post between sections four (4) and thirty-three (33), thence north following the quarter section line to the place of beginning. That the same be and is hereby set apart for incorporation, and incorporated as a village under the corporate name and style of the village of Minnesota Lake to be organized pursuant to chapter one hundred and thirty-nine (139) of the general laws of 1875.

SEC. 2. That N. J. Krimer, W. Lambie, Chancy Barber, S. T. Barns and C. W. Apley, residents of the territory to be incorporated
