CHAPTER 152.

AN ACT TO APPROPRIATE MONEY FOR THE PAYMENT OF INTEREST ON STATE BONDS.

*Be it enacted by the Legislature of the State of Minnesota :*

Appropriation  
for interest on  
State bonds.

SECTION 1. That the sum of thirty-one thousand and five hundred dollars (\$31,500) be and the same is hereby appropriated, out of any money in the State Treasury belonging to the State interest fund, to be expended in payment of interest on State bonds.

CHAPTER 153.

AN ACT TO APPROPRIATE MONEYS FOR THE PURPOSES THEREIN NAMED, FOR THE MINNESOTA STATE PRISON.

*Be it enacted by the Legislature of the State of Minnesota :*

Appropriation  
for improve-  
ments at State  
prison.

SECTION 1. That the following amounts of moneys, or so much thereof as may be necessary, is hereby appropriated for the purposes herein named, out of any moneys in the State treasury not otherwise appropriated:

*First.*—For the enlargement of prison grounds, the sum of four thousand six hundred and fifty dollars (\$4,650).

*Second.*—For the enlargement of the present workshops, the sum of twelve thousand dollars (\$12,000).

*Third.*—For the erection of a blacksmith shop, the sum of two thousand dollars (\$2,000).

*Fourth.*—For the erection of a stone wall on the north side of the prison grounds, the sum of fifteen thousand dollars (\$15,000).

*Fifth.*—For water pipes in enlargement of workshops, the sum of six hundred dollars (\$600).

*Sixth.*—For the payment of the claim of the late deputy warden for house rent, the sum of two hundred and fifteen dollars (\$215).

#### CHAPTER 154.

#### AN ACT TO APPROPRIATE MONEY FOR ERECTING AND FURNISHING BUILDINGS FOR THE MINNESOTA INSTITUTE FOR THE DEAF AND DUMB AND BLIND.

*Be it enacted by the Legislature of the State of Minnesota :*

SECTION 1. That the sum of forty thousand dollars (\$40,000), or so much thereof as may be necessary, is hereby appropriated to be expended in the erection and furnishing of buildings for the Minnesota institute for the deaf and dumb and blind, the same to be paid upon warrants drawn by the president and countersigned by the secretary of the board of directors of that institution, and that on presentation of such warrants to the State Auditor, it shall be his duty to draw warrants on the State Treasurer for like amounts, and such money shall be expended by direction of the board of directors of the said institute. Appropriation for building for deaf, dumb and blind.

SEC. 2. This act shall take effect and be in force from and after its passage. When act to take effect.
