who shall lay the same before said commissioners or supervisors, as the case may be, for their action thereon; and if any person having such claim shall fail to present it as aforesaid, he shall forever be

debarred from farther redress for said damages.

Provided, That nothing in this act shall be so construed as to revive any right or claim for damages now barred by law or the statute of limitation, and provided, further, that any party may appeal from the decision of such supervisors or commissioners as is now provided by law for appeals from awards or damages in laying out county and town roads.

Sec. 3. This act shall take effect and be in force from and after

its passage.

## CHAPTER CCXXXII.

AN ACT TO LEGALIZE THE CORPORATE ORGANIZATION OF CERTAIN RELIGIOUS SOCIETIES, AND PROVIDING FOR THE APPOINTMENT OF TRUSTEES AND OFFICERS THEREOF.

Be it enacted by the Legislature of the State of Minnesota:

Section 1, That the several religious societies hereinafter named that have adopted certificates of incorporation under and by virtue of the provisions of chapter thirty-four, of the general statutes relating to the incorporation of religious societies, and of the acts amendatory thereof, which said societies are named and located as follows, to-wit:

And that the same are severally hereby legalized, and said corporate organizations validated; and that they shall severally have and possess and exercise all and singular the corporate rights, privileges and franchises in said chapter thirty-four, and the acts amendatory thereof conferred upon religious corporations, and that they may severally acquire, hold, possess, convey, mortgage or dispose of real estate, and property as such corporation, or exchange the same for other property upon the concurrence of all the trustees of such society, by resolution to be entered upon the minutes of such corporation, and all deeds and conveyances to said societies or either of them in said corporate name or other pertinent designation, are hereby legalized and validated, and shall be as effectual as though said corporations had been legally organized at the time of the delivering of such conveyance.

SEC. 2. That the corporate name adopted by each of said societies in the certificates of organization aforesaid be and the same shall continue to be in law the corporate name of such society, and that the trustees and other officers of said corporation heretofore elected or appointed, shall continue as such trustees and officers until their respective successors are elected or appointed as in this

act authorized.

SEC. 3. That the trustees and other officers of said several corporations hereafter chosen may be chosen, appointed or designated in conformity to the rules, discipline, constitution and regulations of the Roman Catholic Church, of which church the members of said several religious societies so incorporated are communicants, and the same shall be legal and valid. Anything in the said acts providing a different mode of electing such officers or trustees to the contrary notwithstanding.

Sec. 4. This act shall take effect and be in force from and after

its passage.

## CHAPTER CCXXXIII.

AN ACT TO LEGALIZE PUBLICATION OF THE NOTICE OF TAX JUDGMENT SALE, FOR THE COUNTY, OF STEELE FOR THE YEAR ONE THOUSAND EIGHT HUNDRED AND SEVENTY-EIGHT.

Be it enacted by the Legislatuye of the State of Minnesota:

Section 1. That the publication of the notice of tax judgment sale for the county of Steele for the year one thousand eight hundred and seventy-eight, be and the same is hereby legalized and made valid, and the said publication shall be by all courts and tripbunals treated as a valid and legal publication of the notice of tax judgment sale as fully and completely as if said notice had been published fifteen days before the day of sale.

SEC. 2. This act shall take effect and be in force from and after

its passage.
