

## CHAPTER CCCXXX.

## AN ACT PROVIDING FOR AND ESTABLISHING THE COMPENSATION OF COUNTY OFFICERS IN MEEKER COUNTY.

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. The compensation of all county officers of the county of Meeker, to be hereafter allowed, paid, shall be fixed and established by the board of county commissioners of said county, except the compensation of county commissioners, clerk of the district court, register of deeds, county auditor, county treasurer, sheriff, court commissioner, county surveyor, coroner and judge of probate, which shall be as follows: The county auditor and county treasurer one thousand dollars each; the clerk of district court and register of deeds, such fees and compensation as may be provided by general law; *provided*, that all compensation for personal services in excess of one thousand dollars each shall be paid into the general revenue fund of said county. The sheriff such fees and compensation as may be provided by general law; *provided however*, that all such compensation in excess of one thousand dollars (except for mileage) shall be paid into the general revenue fund of said county. The judge of probate, court commissioner, county surveyor, coroner and county commissioners shall receive such compensation as is or may be provided by general law. *Provided further*, that the county auditor shall continue to receive the same sum annually for clerk hire that he may be entitled to under the general law.

SEC. 2. This act shall take effect and be in force from and after its passage.

## CHAPTER CCCXXXI.

## AN ACT TO PROVIDE FOR THE COMPENSATION AND APPOINTMENT OF JAILER AND TURNKEY IN THE COUNTY OF MOWER, AND STATE OF MINNESOTA.

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. The county commissioners of the county of Mower, in the State of Minnesota, shall determine from time to time the compensation that shall be allowed for the services of a jailor or

turnkey in the county jail of said county of Mower; which compensation shall be paid monthly out of the county treasury, upon the warrant of the county auditor. Such jailor or turnkey to be appointed by the sheriff of said county, subject to the approval of the county commissioners.

SEC. 2. The provisions of chapter forty-three of the general laws of one thousand eight hundred and seventy-three shall not hereafter apply to the county of Mower.

SEC. 3. This act shall take effect and be in force from and after its passage.

## CHAPTER CCCXXXII.

AN ACT TO PROVIDE FOR SUBMITTING THE QUESTION OF THE CONTINUANCE OF THE MUNICIPAL COURT OF THE CITY OF STILLWATER TO A VOTE.

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. That at the election to be held in and for the city of Stillwater on the first Tuesday of April, A. D. one thousand eight hundred and seventy-nine, the question of the continuance of the municipal court of said city shall be submitted to a vote of the legal voters of said city. Those voters wishing to vote upon said question shall have written, printed or endorsed upon their tickets the phrase "for the continuance of the municipal court" and shall under said phrase, write, print or endorse the word no or yes, as the case may be and all tickets endorsed and voted as above shall be canvassed as voted.

SEC. 2. Said election shall be conducted and the votes cast shall be canvassed in all respects as other elections are conducted and canvassed in said city and subject to the same pains and penalties.

SEC. 3. This act shall be in force and take effect from and after its passage.
