

north east quarter of the south west quarter and the north half of the south east quarter of section number three of township number one hundred and two north of range number twenty-three west in the county of Freeborn and state of Minnesota, be and the same is hereby set apart for incorporation as the village of Alden.

SEC. 2. That the following named persons are designated as commissioners under the General Laws of one thousand eight hundred and seventy-five providing for the organization of villages in the state of Minnesota to post notices of the first election and to conduct the same in said village to wit: F. F. Powers, Thos. W. Wilson and A. M. Frigg.

SEC. 3. That upon organization as directed in the General Laws aforesaid of this state, the said territory shall constitute the village of Alden and the inhabitants thereof shall thereupon be endowed with all the rights, powers and duties therein prescribed for organization of villages in the state.

SEC. 4. This act shall take effect and be in force from and after its passage.

## CHAPTER IV.

AN ACT TO INCORPORATE THE VILLAGE OF YOUNG AMERICA IN THE COUNTY OF CARVER, UNDER THE PROVISIONS OF CHAPTER ONE HUNDRED AND THIRTY-NINE OF THE GENERAL LAWS OF THE STATE OF MINNESOTA, FOR THE YEAR A. D. 1875, AND TO CONFER CERTAIN POWERS UPON THE COUNCIL AND ELECTORS OF SAID VILLAGE.

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. The following described territory situate in the town of Young America, in the county of Carver, in this state, to wit: lots one, two, three and four, and the southeast quarter of the southeast quarter of section eleven in township one hundred and fifteen of range twenty-six, and the south one-half of lot one in section twelve in the township and range aforesaid, is hereby set apart for incorporation as a village, under and pursuant to the provisions of chapter one hundred and thirty-nine of the general laws of Minnesota for the year A. D. one thousand eight hundred and seventy-five, and shall and may organize as a municipal corporation by the action of the inhabitants thereof; and the said inhabitants residing within the limits of said above-described territory, are hereby authorized to organize such municipal corporation and village in manner and form as provided in

said chapter one hundred and thirty-nine of the said general laws of Minnesota for the year A. D. one thousand eight hundred and seventy-five, and shall upon becoming organized in the manner aforesaid, be endowed with all the rights, powers and duties mentioned and specified in said chapter one hundred and thirty-nine—all of the provisions of which said chapter shall apply to and be in force in said village of Young America, by which name said municipal corporation shall hereafter be known.

SEC. 2. The village council of said village shall have the exclusive right to restrain, regulate and license the sale, giving away, disposing of or dealing in spirituous, vinous, fermented or malt liquors within the corporate limits of said village; *provided*, that said village council shall not charge more than twenty-five dollars for such license, and all moneys paid for such license shall be paid to the treasurer of said village, for the use and benefit thereof.

SEC. 3. Except for the purposes specified in this act and said chapter one hundred and thirty-nine of the general laws of Minnesota for the year A. D. one thousand eight hundred and seventy-five, the said village shall be and remain a part of the said town of Young America.

SEC. 4. Charles Bachman, Julius Ackerman and Julius Schaller, are hereby designated as the persons to carry out the provisions of section nine of said chapter one hundred and thirty-nine of the general laws of the year one thousand eight hundred and seventy-five, and to issue notice of the first election of officers, to be held in said village, under the provisions of this act and the general law hereinbefore referred to; and the secretary of state is hereby directed to issue his official notification of the passage of this act to said persons.

SEC. 5. This act shall take effect and be in force from and after its passage.
