CHAPTER 124.

AN ACT amendatory to an act entitled "An act to amend an act to incorporate the German Reading Society of St. Paul," approved February twenty-eighth (28), one thousand eight hundred and seventy (1870).

Be tt enocted by the Legislature of the State of Minnesota:

SECTION 1. That section two (2) of chapter one hundred and twenty-four (124) of the Special Laws of one thousand eight hundred and seventy (1870), be and the same is hereby amended by striking the words "such as buildings, apparatus and" out of the fourth and fifth lines of said section as printed in the published session laws of that year.

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 125.

AN ACT to amend chapter three hundred and six (306) of the Special Laws of eighteen hundred and seventy-nine (1879), entitled an act to regulate the salary, compensation and fees of county officers of Rice county.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That section one (1) of said act be amended so as to read as follows:

Section 1. The annual salary of the county auditor shall be eighteen hundred (1800) dollars, and the annual salary of the deputy county auditor shall be one thousand (1000) dollars.

SEC. 2. That section two (2) of said act shall be amended so as to read as follows;

Sec. 2. The annual salary of the county treasurer shall be fifteen hundred (1500) dollars, and the annual salary of the deputy county treasurer shall be six hundred (600) dollars.

SEC. 3. That section four (4) of said act be amended so as to read as follows:

Sec. 4. 'The annual salary of the judge of probate shall be one thousand (1000) dollars, and all amounts collected or received by him pertaining to his office shall be paid over to the county treasurer and be placed to the credit of the county revenue fund.

. SEC. 4. That section seven (7) of said act be, and the same is hereby repeated.

SEC. 5. This act shall take effect and be in force from and after the first day of April, 1881.

CHAPTER 126.

AN ACT to amend chapter eighty-four (84) of the Special Laws of one thousand eight hundred and seventy-five (1875), entitled an act to provide fishways on the Zumbro river, between its mouth and Oronoco village and the city of Rochester.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That section one (1) of chapter eighty-four (84) of the Special Laws of eighteen hundred and seventy-five (1875) be so amended as to read as follows: "That all persons now owning or having dams or obstructions (or who may hereafter build dams or obstructions) across the Zumbro river, anywhere between the mouth of said river and the village of Pine Island and the city of Rochester, shall, under the penalties hereinafter provided, construct fish-ways as described in section two (2) of this act, by means of which fish can pass or ascend from the waters below said dam or obstruction to the waters above, and shall keep said fish-ways in good repair, that they may be available for the purpose intended."

SEC. 2. This act shall take effect and be in force from and after its passage.

Approved March 4, 1881.
