

CHAPTER 133.

AN ACT to amend an act entitled an act to locate a State road on the county line between the counties of Scott, Le Sueur and Rice, the same being chapter two hundred and fifty-one (251), Special Laws of one thousand eight hundred and seventy-nine (1879).

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That section one (1) of chapter two hundred and fifty-one (251) Special Laws of one thousand eight hundred and seventy-nine (1879), be amended by striking therefrom the names of Albert Borak, Philip Plaisance and Patrick O'Flynn and inserting in place of the names stricken out John Lundenberger, James Sticha and W. E. Gunnel.

Sec. 2. That section two (2) be amended by striking out eighteen hundred and seventy-nine (1879) and inserting in lieu thereof eighteen hundred and eighty-one (1881).

Sec. 3. That section four (4) be amended by striking out therefrom eighteen hundred and seventy-nine (1879) and inserting in lieu thereof eighteen hundred and eighty-one (1881).

Sec. 4. No damages for right of way for such road shall be chargeable to or paid by the towns of Cedar Lake, Newmarket or the county of Scott as a county.

Sec. 5. This act shall take effect and be in force from and after its passage.

CHAPTER 134.

AN ACT in relation to the Public Schools of Brainerd, Minnesota.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the territory now embraced in the independent school district of Brainerd, in the county of Crow Wing, Minnesota, be incorporated as a school district for the better regulation and management of the public schools in said district, to be known and described as the Brainerd school district.

SEC. 2. That said Brainerd school district be declared to be the successor of said independent school district of Brainerd, and all property and assets of said independent district are hereby trans-

ferred to and all liabilities thereof are assumed and are to be paid by said Brainerd school district.

SEC. 3. That said district shall be governed by and subject to the General Laws governing independent school districts in this State, except otherwise especially provided in this act.

SEC. 4. The board of education of said district shall have the custody, safe keeping and control of the school houses, lots, sites and appurtenances, books, furniture and all school property belonging to the district; shall contract with and employ all teachers in the public schools of the district, and at their pleasure remove them. They shall have power, and it shall be their duty in all respects to control and manage the public schools of the district, with power to adopt, alter and repeal rules and regulations for their organization, grading and government, for the instruction and discipline of pupils, their admission, suspension and expulsion, and their transfer from one school or grade to another; to decide upon the text books to be used; to prescribe special studies in the higher grades of said schools not provided for in the general laws, and to promote the good order, prosperity and public utility of said schools; to make all necessary by-laws for the government and manner of transacting the business of the board, and for conducting and regulating the schools, and to alter and repeal the same, as they may deem expedient.

SEC. 5. This act shall be deemed a public act, and shall take effect and be in force from and after its passage.

CHAPTER 135.

AN ACT to authorize the County Commissioners of Blue Earth County to detach certain territory from independent school district number sixteen (16) and attach the same to school district number ninety (90) in said county.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. The county commissioners of Blue Earth county are hereby authorized and empowered, in their discretion, to detach the following territory from independent school district number sixteen (16) and attach the same to, and make it a part of school district number ninety (90) in said county, to-wit: The east half (E. $\frac{1}{2}$) of the north-east quarter (N.-E. $\frac{1}{4}$) and the east half (E. $\frac{1}{2}$) of the south-east quarter (S.-E. $\frac{1}{4}$) and the east half (E. $\frac{1}{2}$) of the north-west quarter (N.-W. $\frac{1}{4}$) of the south-east quarter (S.-E. $\frac{1}{4}$) of section twenty-four (24), and the east half (E. $\frac{1}{2}$) of the north-east quarter (N.-E. $\frac{1}{4}$) of section twenty-five (25), all in township num-
