SPECIAL LAWS

CHAPTER 163.

AN ACT to create a new school district in the towns of Redrock and Dexter, in Mower county, Minnesota.

Be it enacted by the Legislature of the State of Minnesota;

SECTION 1. That the south half $(\frac{1}{2})$ of section thirteen (13), the south half $(\frac{1}{2})$ of section fourteen (14), the southeast quarter $(\frac{1}{4})$ of section fifteen (15), the south half $(\frac{1}{2})$ of the northeast quarter $(\frac{1}{4})$ of section fifteen (15), the northeast quarter $(\frac{1}{4})$ of section twenty-one (21), the north half $(\frac{1}{2})$ of section twenty-two (22), the southeast quarter $(\frac{1}{4})$ of section twenty-two (22), the west half $(\frac{1}{2})$ of section twenty-three (23), the northeast quarter $(\frac{1}{4})$ of section twenty-three (23), the northwest quarter $(\frac{1}{4})$ of section twenty-six (26), the northeast quarter $(\frac{1}{4})$ of section twenty-seven (27) in township one hundred and three (103), range seventeen (17); also, the east half $(\frac{1}{2})$ of section eighteen (18), the southeast quarter $(\frac{1}{4})$ of the southwest quarter $(\frac{1}{4})$ of section eighteen (18), and the west half $(\frac{1}{2})$ of the northwest quarter $(\frac{1}{4})$ and the west half $(\frac{1}{2})$ of the southwest quarter $(\frac{1}{4})$ of section eighteen (18) in township one hundred and three (103), range sixteen (16), be and the same is hereby constituted a school district for all common school purposes whatsoever, and to be known hereafter as school district number one hundred and sixteen (116). *Provided*, that the new district hereby created shall be held and remain levied [liable] for its just proportion of all indebtedness of the district of which it is formed, and shall be entitled to its proportionate part of all funds in the treasuries of said districts belonging to the same not required to pay such indebtedness.

SEC. 2. All acts and parts of acts inconsistent with this act are hereby repealed.

SEC. 3. This act shall take effect and be in force from and after its passage.

CHAPTER 164.

AN ACT to detach certain territory from school district number six (6) and attach the same to independent school district number seven (7), in the county of Wright.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the north half $(\frac{1}{2})$ of the southeast quarter $(\frac{1}{4})$ and the south half $(\frac{1}{2})$ of the northeast quarter $(\frac{1}{4})$ of section nine (9). in township one hundred and twenty-one (121), in range

twenty-five (25), in the county of Wright and State of Minnesota, now belonging to and being a part of school district number six (6), in said county of Wright, is hereby detached and set off from school district number six (6) and attached to and included in independent school district number seven (7), in Wright county aforesaid.

SEC. 2. This act shall take effect and be in force from and affer its passage.

CHAPTER 165.

AN ACT to change the boundaries of school district number three (3), of Yellow Medicine county.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the boundary lines of school district number three (3), of Yellow Medicine county, be changed so as to include in school district number three (3) only that portion of school district number three (3) lying in township number one hundred and fifteen (115). range number thirty-nine (39).

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 166.

AN ACT to reduce the boundaries of independent school district number.one (1), in Redwood county.

Be it enacted by the Legtslature of the State of Minnesota:

SECTION 1. That all of sections twenty-five (25) and twentysix (26), township one hundred and thirteen (113), range thirtysix (36), in Redwood county, now a part of independent school district number one (1), in said county, be and hereby are set off from said independent school district for all purposes whatsoever. SEC. 2. This act shall take effect and be in force from and af-
