CHAPTER 311.

AN ACT relating to the running at large of cattle, horses, sheep, swine and other domestic annimals, in the county of Houston, in the State of Minnesota.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. That it shall be unlawful for any person or persons to allow cattle, horses, sheep, swine or other domestic animals owned by such person or persons, or of which such person or persons have control, or who may be in the possession of the same, to run at large upon any of the public highways, or upon the lands of any other person or persons, in the county of Houston, in the State of Minnesota, during any season of the year, unless they are carefully herded.

SEC. 2. The owner or owners, or any person or persons having control, or having in possession, of any cattle, horses, sheep, swine, or other domestic animals, as aforesaid, shall be liable in an action at law for all damages done by such animals, without regard to any fence, or the sufficiency of any fence or fences on the lands on which the damage is done. The provisions of this act shall apply only to the township of Blackhammer, of said Houston county.

SEC. 3. This act shall take effect and be in force from and after its passage.

CHAPTER 312.

AN ACT to prohibit cattle and other domestic animals from running at large in township one hundred and twenty-one (121) range thirty-nine (39) in the county of Swift and State of Minnesota.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. That it shall be unlawful for any person or persons to allow any cattle, horses, asses, mules, sheep, or swine owned by such person or persons or of which such person or persons have con rol or may be in possession of, to run at large on any public highway, or upon the lands of any other person or persons in township one hundred and twenty-one (121) range thirty-nine (39) called

the town of Torning, in the county of Swift, State of Minnesota, during any season of the year unless such animal or animals are

carefully herded.

Sec. 2. Any person or persons who shall violate or neglect the provisions of the first (1st) section of this act shall be liable for all damages that may occur in consequence of such animal or animals.

SEC. 3. This act shall take effect and be in force from and after

its passage.

CHAPTER 313.

AN ACT relating to the running at large of cattle in the town of Kirkhoven.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. That chapter fifty-three (53) of the General Laws of eighteen hundred and seventy-four (1874) and more especially the first (1st) proviso contained in section two (2) of said chapter fifty-three (53) shall be in full force in the town of Kirkhoven, in Swift county, State of Minnesota, anything in said chapter to the contrary notwithstanding.

SEC. 2. This act shall take effect and be in force from and af-

ter its passage.

CHAPTER 314.

AN ACT to prevent the running at large of cattle or other domestic animals in the county of Hennepin, State of Minnesota.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. That it shall be unlawful for any person or persons to allow any cattle, horses, sheep, swine or other domestic animals owned by such person or persons or of which such person or persons have control or may be in possession to run at large upon any public highway or upon the lands of any other person or persons in the county of Hennepin, State of Minnesota, during any season of the year, unless such animal or animals are properly herded.
