

CHAPTER 330.

AN ACT to legalize the acts of commissioners surveying and locating a State road from Fergus Falls in Otter Tail county to Herman in Grant county.

Be it enacted by the Legislature of the State of Minnesota :

SECTION 1. That the acts of the commissioners in surveying and locating a State road from Fergus Falls in Otter Tail county to Herman in Grant county, pursuant to an act of the legislature approved March sixth (6th), one thousand eight hundred and seventy-nine (1879), are hereby legalized, and the said road as surveyed and located by said commissioners is hereby declared to be a legal highway. *Provided*, that nothing in this act contained shall be construed to effect, impair or in anywise prejudice any private rights as they exist under the constitution and laws of this State.

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 331

AN ACT to legalize the organization of the Hassan German Mutual Fire Insurance Company.

Be it enacted by the Legislature of the State of Minnesota :

SECTION 1. That the Hassan German Mutual Fire Insurance Company, of the county of Hennepin, a corporation organized under chapter thirty-four (34), General Statutes of one thousand eight hundred and seventy-eight (1878), relating to town insurance companies, as amended by chapter twenty-six (26) of the General Laws of one thousand eight hundred and seventy-nine (1879), is hereby declared to be a legally organized company, with all the powers and rights which attach to companies duly organized under said chapter thirty-four (34) of the General Statutes of one thousand eight hundred and seventy-eight (1878), relating to town insurance companies, as the same stands amended by chapter forty of the General Laws of one thousand eight hundred and seventy-nine (1879), and all the acts done and performed by the said Has-

an German Mutual Fire Insurance Company, its officers and agents, not inconsistent with its articles of incorporation and the General Laws of this State relating to the organization of town insurance companies, are hereby legalized and made valid as the corporate acts of said company.

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 332.

AN ACT to legalize and confirm the organization of all organized towns in Redwood county.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the organization of the following named towns in the county of Redwood and State of Minnesota, to wit: Brookville, Morgan, Sherman, Homer, Paxton, Three Lakes, Sundown, Charleston, Willow Lake, New Avon, Redwood Falls, Delhi Swede Forrest, Kentric, Sheridan, Vail, Waterbury, Lamberton, North Hero, Johnsonville, Vesta, Underwood, West Lin, Gates and Springdale be, and the same is, hereby legalized and made valid to all intents and purposes.

SEC. 2. That all the acts and proceedings of the board of county commissioners of said county of Redwood in organizing said towns as now organized, be, and hereby are legalized, made valid and effectual to all intents and purposes, and shall have the same force and effect as if said acts and proceedings had been in all respects in conformity to the provisions of the statutes of the State of Minnesota in such case made and provided.

SEC. 3. This act shall take effect and be in force from and after its passage.

CHAPTER 333.

AN ACT to change the names of certain persons therein named.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the name of Lewis Nelson, of the county of Kandiyohi, is hereby changed to Lars A. Rane.

SEC. 2. The name of John A. Carlson of the county of Chisago, is hereby changed to John A. Fornell.
