CHAPTER 338.

AN ACT to change the name of Oak Lake, in Becker county, to Audubon.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the name of the town of Oak Lake, in Becker county, be and is hereby changed to that of Audubon.

SEC. 2. This act to take effect and be in force from and after its passage.
