in any proceeding or action in which the village of Red Lake Falls

shall be a party in interest.

SEC. 19. If any election by the people or village council shall for any cause not be held at the time nor in the manner herein prescribed it shall not be considered reason for arresting, suspending or absolving said corporation, but such election or organization may be had in any subsequent day by order of the village council; and if any of the duties enjoined by this act, or the ordinances or by-laws of the village to be done by any officer at any specified time and the same are not so done or performed, the village council may appoint another time which the said acts may be done and performed.

Sec. 20. No law of this State contravening the provisions of this act shall be considered as repealing, amending or modifying the same unless such purpose be expressly set forth in such law.

SEC. 21. This act is a public act and need not be pleaded or

proven in any court in this State.

SEC. 22. Said village shall not be organized unless authorized by a majority vote of the qualified voters of the territory described in section one (1) of this act; and such vote shall be taken at the time and place of the first election provided for in this act, and the same proceedings had and result declared by the inspectors named in section four (4) thereof. And those voting in favor of such organization shall have written or printed or partly written and partly printed on the ballots used "For organization," and those voting against said organization, the words "Against organization."

SEC. 23. This act shall take effect and be in force from and

after its passage.

## CHAPTER 41.

AN ACT TO INCORPORATE THE VILLAGE OF RENVILLE, IN THE COUNTY OF RENVILLE, AND STATE OF MINNESOTA.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. The following parts of the territory of the county of Renville, in this State, to-wit: The south one half  $(\frac{1}{2})$  of the northwest one quarter  $(\frac{1}{4})$ , and the southwest one quarter  $(\frac{1}{4})$  of the northeast one quarter  $(\frac{1}{4})$  and the west one half  $(\frac{1}{2})$  of the southeast one quarter  $(\frac{1}{4})$ , and the southwest one quarter  $(\frac{1}{4})$  all of section numbered five  $(\frac{5}{4})$  and the northwest one quarter  $(\frac{1}{4})$  of the northeast one quarter  $(\frac{1}{4})$  of section numbered eight (8), all in town-

ship numbered one hundred and fifteen (115) north, in range numbered thirty-six (36) west, and the people now and hereafter inhabiting the said parts of the said territory are hereby created and declared to be a village corporation, under the provisions of that certain act of the legislature approved March 4, A. D. one thousand eight hundred and seventy-five (1875), entitled, "an act to provide for the organization of villages in the State of Minnesota," and of the subsequent acts of the legislature relating to the same subject matter under the name of "the village of Renville.

SEC. 2. John B. Boyd, Wm. F. Baade and P. Williams, residents of the said territory hereby incorporated, are hereby appointed commissioners to perform the acts relating to the organization of the said village prescribed by section nine (9) of the said act of the year one thousand eight hundred and seventy-five (1875).

SEC. 3. This act shall take effect and be in force from and after

its passage.

## CHAPTER 42.

AN ACT TO ICORPORATE THE VILLAGE OF SPRINGFIELD, COUNTY OF BROWN IN THE STATE OF MINNESOTA.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. That the following described territory in the county of Brown, State of Minnesota, to wit: the south one half (\frac{1}{2}) of the southeast quarter (S. E. \frac{1}{2}) of section eighteen (18); the south-east quarter (S. E. \frac{1}{2}) of southwest quarter (S. W. \frac{1}{2}) of section eighteen (18); the northwest quarter (N. W. \frac{1}{2}) of the northeast quarter (N. E. \frac{1}{2}) of section ninteen (19); and the northeast quarter (N. E. (\frac{1}{2})) of the northwest quarter (N. W. \frac{1}{2}) of section ninteen (19), all in Town 109. Range 34, be and the same is hereby set apart and constituted the village of Springfield under the provisions of chapter one hundred and thirty-nine (139) of the general laws of the State of Minnesota for the year one thousand eight hundred and seventy-five (1875) and the amendments thereto.

SEC. 2. That John Bagan, M. H. Gamble, J. D. Ray are hereby designated as commissioners to carry out the provisions of section nine (9) of said chapter one hundred and thirty-nine (139), and the secretary of the state is hereby directed to issue his official notifi-

cation of the passage of this act.

SEC. 3. This act shall take effect and be in force from and after its passage.
