CHAPTER 180.

AN ACT TO PROVIDE CONCERNING THE RUNNING AT LARGE OF HORSES, CATTLE, SHEEP, MULES AND HOGS, IN THE COUNTIES OF DOUGLAS AND POPE.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That in the said counties of Douglas and Pope a majority of the legal voters in each town may determine by ballot, at the next annual town meeting after the passage of this act, whether horses, mules, cattle, sheep and hogs shall be permitted to run at large in such town; and for the purpose of determining such question, those in favor of permitting horses, cattle, sheep, mules and hogs to run at large in such town, shall have written or printed or partly written and partly printed on their ballots, the words, "in favor of the running at large of horses, cattle, sheep, mules and hogs," and those against the running at large of horses, cattle, sheep, mules and hogs in such town, shall have written or printed, or partly written and partly printed on their ballots, the words, "against the running at large of horses, cattle, sheep, mules and hogs," such votes shall be canvassed and returns thereof made in the same manner that votes for town officers are canvassed and returned; and if upon a canvass of said votes by the board of town canvassers, it shall be ascertained that a majority of such voters have voted for the running at large of aforesaid animals, in such town, then it shall be lawful for cattle to run at large in such town. subject to the provisions of the general laws of the State, relating to animals doing damage, but if a majority of the voters in such town shall vote against the running at large of such animals aforesaid, in that case it shall not be lawful for animals to run at large in such town.

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 181.

AN ACT TO PREVENT THE RUNNING AT LARGE OF CATTLE AND OTHER DOMESTIC ANIMALS IN THE TOWNS OF LICTHFIELD AND COLLINWOOD, IN MEEKER COUNTY, STATE OF MINNESOTA.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That it shall be unlawful for any person or persons to allow [any] cattle, horses, mules, asses, sheep, or swine, owned by them or of which they may have possession or control, to run at large upon the public highways or upon the lands of any other person during any season of the year, in the towns of Litchfield and Collinwood, in Meeker county, State of Minnesota.

SEC. 2. Any person or persons who shall violate or neglect the provisions of the first (1st) section of this act, shall be liable for all damages that may occur in consequence of the trespass of such animal or animals.

SEC. 3. This act shall take effect and be in force from and after its passage.

CHAPTER 182.

AN ACT TO AUTHORIZE THE SUPERVISORS OF THE TOWN OF CHAS-KA, TO REGULATE THE RUNNING AT LARGE OF CATTLE, HORSES AND OTHER DOMESTIC ANIMALS IN A PORTION OF THE TOWN OF CHASKA, CARVER COUNTY.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That unless otherwise ordered by the board of supervisors of the town of Chaska, in the county of Carver, it shall be unlawful for cattle, horses, sheep or other domestic animals to run at large in that portion of the town of Chaska, which is over-flowed by water from the Minnesota river at the ordinary high water stage of said river. *Provided*, That this act shall not apply to any part of said town included within the limit of the village of Chaska.

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 183.

AN ACT TO PREVENT THE RUNNING AT LARGE OF CATTLE OR OTHER DOMESTIC ANIMALS IN THE TOWN OF OAKDALE AND THE TOWN OF GRANT, OF WASHINGTON COUNTY, STATE OF MINNE-SOTA.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. It shall be unlawful for any person or persons to allow any cattle, horses, mules, sheep or swine owned by such person or persons or of which such person or persons have control or may be in possession of, to run at large upon any public highway or upon the lands of any other person or persons in the town of
