

CHAPTER 75.

AN ACT TO AMEND AN ACT ENTITLED "AN ACT TO REGULATE THE SALARY, COMPENSATION AND FEES OF COUNTY OFFICERS OF GOODHUE COUNTY," APPROVED MARCH SIXTH (6TH), ONETHOUSAND EIGHT HUNDRED AND SEVENTY-NINE (1789), BEING CHAPTER THREE HUNDRED AND SEVEN OF THE SPECIAL LAWS OF ONE THOUSAND EIGHT HUNDRED AND SEVENTY-NINE (1879), AND AN ACT AMENDATORY THEREOF, APPROVED FEBRUARY FIFTH (5TH), ONE THOUSAND EIGHT HUNDRED AND EIGHTY-ONE (1881), BEING CHAPTER ONE HUNDRED AND SEVEN (107) OF THE SPECIAL LAWS OF ONE THOUSAND EIGHT HUNDRED AND EIGHTY-ONE (1881).

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. Section one (1) of chapter three hundred and seven (307) of the special laws of one thousand eight hundred and seventy-nine (1879), as amended by chapter one hundred and seven (107) of the special laws of one thousand eight hundred and eighty-one (1881), be and the same is hereby amended to read as follows:

Sec. 1. The annual salary of the county auditor shall be two thousand dollars (\$2,000), for his personal services, in addition to which he shall be allowed for clerk hire at the rate now fixed by law, but not to exceed the sum of one thousand four hundred dollars (\$1,400), in any one year, provided that the county commissioners may allow a reasonable compensation for any extra services performed by said auditor, upon the authority or approval of said commissioners.

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 76.

AN ACT TO AMEND CHAPTER THREE HUNDRED AND FIFTY-FOUR (354) OF THE SPECIAL LAWS OF ONE THOUSAND EIGHT HUNDRED AND EIGHTY-ONE (1881), AS AMENDED BY CHAPTER SEVENTY-ONE (71) OF THE SPECIAL LAWS OF ONE THOUSAND EIGHT HUNDRED AND EIGHTY-THREE (1883), PRESCRIBING THE SESSIONS OF THE BOARD OF COMMISSIONERS OF STEARNS COUNTY.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That section three (3) of chapter three hundred and fifty-four (354) of the special laws of Minnesota for the year one

thousand eight hundred and eighty-one (1881), as amended by section two (2) of chapter seventy-one (71) of the special laws of one thousand eight hundred and eighty-three (1883), be and the same is hereby amended so as to read as follows: No commissioner of said county, except the chairman of the board, shall receive pay for more than forty-five (45) days' services in any one year, including all services rendered in general and special sessions, upon committees or for any other object or purpose, and the chairman of said board shall not receive pay for more than sixty (60) days in anyone year for like services, and the auditor of said county is hereby prohibited from issuing orders to any of said commissioners for more than said number of days for services in any one year, except as provided in section four (4) of said act.

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 77.

AN ACT TO AMEND SECTION ONE (1) OF CHAPTER TWO HUNDRED AND ONE (201) OF SPECIAL LAWS OF ONE THOUSAND EIGHT HUNDRED AND EIGHTY-THREE (1883), APPROPRIATING MONEY TO AID JACKSON COUNTY IN CONSTRUCTING A BRIDGE ACROSS THE DES MOINES RIVER.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That said act be amended by striking out on line five (5) of said section one (1), after the word "river," all of said section to the word "in" on line seven (7), also on line nine (9) of same section, striking out the words "thirty-three" and inserting the words "thirty-five."

SEC. 2. This act shall take effect and be in force from and after its passage.
