

*Sixteenth*—For payment of claims of persons who have complied with the act of one thousand eight hundred and seventy-three (1873) providing for a bounty for planting trees, twenty-five hundred dollars (\$2,500).

*Seventeenth*—For repairs and furnishing capitol, three thousand dollars (\$3,000).

*Eighthteenth*—For rent of telephone instruments at the capitol one hundred dollars (\$100).

*Nineteenth*—For payment of a stenographer for the offices of governor and attorney general, twelve hundred dollars (\$1,200).

*Twentieth*—For the payment of fees of referees of district courts as provided by chapter fifty-five (55) of the general laws of one thousand eight hundred and eighty-five (1885), two thousand dollars (\$2,000).

*Twenty-first*—For additional clerk hire in the attorney general's office, fifteen hundred dollars (\$1,500).

## CHAPTER 223.

[H. F. No. 957.]

### AN ACT TO APPROPRIATE MONEY FOR CERTAIN PURPOSES THEREIN NAMED.

*Be it enacted by the Legislature of the State of Minnesota:*

Appropriation  
for various  
expenses and  
deficiencies.

SECTION 1. That the following sums of money, or so much thereof as may be necessary, be, and the same are hereby appropriated from any moneys in the state treasury belonging to the general revenue fund, or that may hereafter be received to the credit of said fund.

*First*—For deficiency for printing, binding and advertising for the several departments and offices as provided by contract for the year ending July thirty-first (31st), one thousand eight hundred and eighty-seven (1887), the sum of twenty thousand dollars (\$20,000).

*Second*—For deficiency for payment of expenses of sheriffs conveying convicts to the state prison for the year ending July thirty-first (31st), one thousand eight hundred and eighty-seven (1887), two thousand dollars (\$2,000).

*Third*—For deficiency for payment of rewards for capture and conviction of horse thieves for the year ending

July thirty-first (31st), one thousand eight hundred and eighty-seven (1887), one thousand dollars (\$1,000).

*Fourth*—For payment of deficiency in contingent appropriation for the office of superintendent of public instruction for the year ending July thirty-first (31st), one thousand eight hundred and eighty-seven (1887), two hundred dollars (\$200).

*Fifth*—For deficiency in appropriation for payment of the salary of the janitor of the supreme court for the year ending July thirty-first (31st) one thousand eight hundred and eighty-five (1885), one hundred and twenty-five dollars (\$125).

*Sixth*—For payment for the services of a stenographer in the offices of the governor, the attorney-general for the year ending July thirty-first (31st), one thousand eight hundred and eighty-seven (1887), six hundred dollars (\$600.)

*Seventh*—For the payment of interest on warrants issued by the state auditor for current expenses since November first (1st), one thousand eight hundred and eighty-six (1886), three thousand dollars (\$3,000).

*Eighth*—For the payment of additional help for care of capitol and grounds for the year ending July thirty-first (31st), one thousand eight hundred and eighty-seven (1887), one hundred and twenty-eight dollars and twenty-six cents (\$128.26).

*Ninth*—For the payment of deficiency for contingent expenses of the supreme court for the year ending July thirty-first (31st), one thousand eight hundred and eighty-seven (1887), three hundred dollars (\$300), payable only upon the order of a justice of the supreme court.

*Tenth*—For the payment of fees of referees of district courts, as provided by chapter fifty-five (55) of the general laws of eighteen hundred and eighty-five (1885), two thousand dollars (\$2,000.)

*Eleventh*—For payment of expenses of J. H. Baker, incurred while railroad commissioner in eighteen hundred and eighty-three (1883) and eighteen hundred and eighty-four (1884), for which no appropriation has heretofore been made, two hundred and fifty-six dollars (\$256).

*Twelfth*—For the payment of services and expenses of C. D. Kerr and D. B. Searle as attorneys for the state in contesting tax sales in Crow Wing and Morrison counties in eighteen hundred and seventy-eight (1878) and subsequent years, nine hundred and forty-three dollars and sixty-eight cents (\$943.68).

*Thirteenth*—For publishing the general laws of the present session of the legislature in the newspapers, thirty-five thousand dollars (\$35,000).

*Fourteenth*—For additional clerk hire in the office of auditor and land commissioner for the year ending July

thirty-first (31st), eighteen hundred and eighty-seven (1887), seven hundred and fifty dollars (\$750).

*Fifteenth*—For clerk hire in the office of the superintendent of public instruction for the year ending July thirty-first (31st), eighteen hundred and eighty-seven (1887), seven hundred and fifty dollars (\$750).

*Sixteenth*—For repairs and furnishing the capitol building for the year ending July thirty-first (31st), eighteen hundred and eighty-seven (1887), one thousand dollars (\$1,000).

*Seventeenth*—For payment of J. F. Williams for services as secretary of the State Forestry Association, one hundred dollars (\$100), payable from the forestry fund.

*Eighteenth*—For an additional amount for expenses of the present session of the legislature, five thousand dollars (\$5,000).

*Nineteenth*—For completing the engine house and arranging it for the electric light plant, fifteen hundred dollars (\$1,500).

*Twentieth*—For purchase of dynamos, lamps, and other necessary fixtures for an isolated electric light plant for lighting the capitol five thousand dollars (\$5,000), to be expended upon the order of the fuel commission.

*Twenty-first*—For payment of services of James B. Beals, attorney, in defense of two test suits now in the supreme court of the United States on appeal taken by the railroad company, rendered under chapter one hundred and seventy-six (176) of the general laws of eighteen hundred and eighty-five (1885), to be in full for all such services, one thousand dollars (\$1,000) to be paid upon the order of the attorney-general.

*Twenty-second*—For deficiency in appropriation for stationary for legislature and state officers for year ending July thirty-first (31st), eighteen hundred and eighty-seven (1887), fifteen hundred dollars (\$1,500).

*Twenty-third*—For payment of a clerk in charge of stationery in the secretary of state's office during present session of the legislature, two hundred dollars (\$200).

*Twenty-fourth*—For additional clerk hire in the office of the attorney-general, six hundred and twenty-five dollars (\$625).

*Twenty-fifth*—For indexing general and special laws of the year eighteen hundred and eighty-seven (1887), to be done under the direction of the attorney-general two hundred dollars (\$200).

*Twenty-sixth*—For payment of assessments for grading and opening streets adjacent to reform school grounds and state arsenal lot in West St. Paul, fourteen hundred and nine dollars and seventy-eight cents (\$1,409.78).

*Twenty-seventh*—For an additional amount for salary of

theadjutant-general, one thousand two hundred and ninety-one dollars and sixty-nine cents (\$1,291.69).

SEC. 2. This act shall take effect and be in force from and after its passage.

## CHAPTER 224.

[S. F. No. 619.]

AN ACT TO APPROPRIATE MONEYS FOR THE BALANCE DUE UPON PERMANENT IMPROVEMENTS FOR THE STATE AGRICULTURAL SOCIETY.

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. There is hereby appropriated out of any moneys in the treasury, not otherwise appropriated, the sum of fifty thousand (50,000) dollars, payable in equal installments of twenty-five thousand (25,000) dollars each in eighteen hundred and eighty-eight (1888) and eighteen hundred and eighty-nine, (1889), for the purpose of paying the balance due upon and for the permanent buildings, built by the state agricultural society upon said society's grounds, which said moneys shall be paid to the treasurer of said state agricultural society upon the order of the president of said society, attested by the secretary of the same.

Appropriation for state agricultural society.

SEC. 2. This act shall take effect and be in force from and after its passage.
