CHAPTER 224.

AN ACT TO AUTHORIZE THE PEOPLE OF THE TOWNSHIP OF ST. JAMES, IN WATONWAN COUNTY, TO HOLD TOWN MEETINGS AND GENERAL ELECTIONS WITHIN THE INCORPORATED LIMITS OF THE VILLAGE OF ST. JAMES.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. That the people of the township of St. James in Watonwan county, be and are hereby authorized to hold their town meetings and general elections in the village of St. James in said Watonwan county, and the supervisors of said township are authorized to meet in said village the same as provided by statute for meeting in the township.

SEC. 2. This act shall take effect and be in force from and after.

CHAPTER 225.

[H. F. No. 933.]

AN ACT TO AUTHORIZE THE VILLAGE OF CLEARWATER AND THE TOWN OF GLEARWATER, IN WRIGHT COUNTY, AND THE TOWN OF CLEAR LAKE IN SHERBURNE COUNTY, TO RAISE A FUND BY TAXATION TO ESTABLISH AND MAINTAIN A FREE FERRY ACROSS THE MISSISSIPPI RIVER,

Be it enacted by the Legislature of the State of Minnesota:

Section 1. The village of Clearwater and the township of Clearwater, in Wright county, and the town of Clear Lake, in Sherburne county, are hereby authorized, subject to the provisions hereinafter contained, to raise by taxation, a sum not to exceed fifteen hundred (1500) dollars for the year 1887, and five hundred (500) dollars annually thereafter, which shall be expended by and under the direction of the village council of the village of Clearwater, and the board of supervisors of the town of Clearwater, in Wright county, and the board of supervisors of the town of Clear Lake, in Sherburne county, in maintaining a free ferry for the passage of foot passengers, teams and stock across the Mississippi river at Clearwater at such point as may be agreed upon by a majority of said council and boards.

SEC. 2. At the next election hereafter to be held in said village of Clearwater and town of Clearwater, and town of Clear Lake, the

question shall be submitted to the voters, of raising the sum herein-before mentioned for the purpose hereafter mentioned. At such election the voters shall vote by ballots written or printed, or partly written and partly printed. Those in favor of raising such tax to have written or printed thereon, or partly written and partly printed thereon, "For aid to ferry—yes." Those voting against such taxation shall vote by ballots having written or printed thereon or partly written and partly printed thereon the words, "For aid to ferry—no." If a majority of all the votes cast in each, said village of Clearwater, town of Clearwater and town of Clear Lake shall be in favor of such aid, such taxes shall thereupon be raised, not to exceed the sum above mentioned.

SEC. 3. Nothing in this act contained shall be construed as conferring any special privilege or exclusive rights upon any person or cor-

poration.

SEC. 4. This act shall take effect and be in force from and after its passage.

CHAPTER 226.

AN ACT TO AUTHORIZE THE COUNTY COMMISSIONERS OF HENNE-PIN COUNTY MINNESOTA, TO MAKE WORKING PLATS FOR THE AUDITORS OFFICE.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. The county commissioners of Hennepin county, Minnesota, are hereby authorized to appropriate out of the treasury of said county the sum of two thousand five hundred (2,500) dollars or so much thereof as may be necessary, for the purpose of having made and kept, for the use of the auditors office of said Hennepin county, a set of working plats of all unplatted or irregularly subdivided lands or lots in said county.

SEC. 2. The county auditor shall have charge of and supervise the drafting and making of said plats and after said plats shall have been completed, it shall be the duty of said auditor at least once in each

month to have said plats corrected and brought down to date.

SEC. 3. It shall be the duty of the county auditor of said county to have made and to furnish to the assessors of each assessment district of said county, tracings or copies of said plats in the same manner and at the same time that he is by law now directed to furnish said assessors copies of recorded plats to accompany the assessment rolls.

SEC. 4. This act shall take effect and be in force from and after

its passage.
