## CHAPTER 286.

[S. F. No. 581.]

ANA CT TO LEGALIZE THE ARTICLES OF INCORPORATION OF THE CHRISTIAN APOSTOLIC BAPTIST SOCIETY OF HUTCHINSON, MINNESOTA, AND THE ACTS OF THE OFFICERS AND MINISTERS THEREOF.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the articles of incorporation of the Christian Apostolic Baptist Society of Hutchinson, Minnesota, heretofore filed for record in the office of the register of deeds in and for McLeod county, on the seventeenth (17th) day of February, one thousand eight hundred and eighty-seven (1887), and in the office of the secretary of state on the twenty-first (21st) day of February, one thousand eight hundred and eighty-seven (1887), be and the same are

hereby legalized and declared valid.

SEC. 2. That the trustees of said society are hereby authorized and empowered to do and perform any and all of the acts and duties which by said articles of incorporation they are so authorized and empowered to do and perform, in accordance with and in conformity to the by-laws of said society; that any and all credential granted and issued by said trustees in conformity to said articles of incorporation and by-laws are hereby declared valid, and the persons to whom such credentials are granted and issued are hereby declared ordained ministers of the gospel and are hereby authorized and empowered to do and perform any and all acts and ceremonies authorized by law to be done and performed by any ordained minister of the gospel, so long as he shall remain in regular communion with a religious society, and any and all acts and ceremonies so done and performed by such minister are hereby declared to be valid and legal for all purposes.

SEC. 3. This act shall take effect and be in force from and after

its passage.

## CHAPTER 287.

AN ACT TO LEGALIZE AND CONFIRM CERTAIN ACTS OF THE COM-MON COUNCIL OF THE CITY OF SAINT PAUL, MINNESOTA, RELAT-ING TO THE VACATION OF STREETS AND ALLEYS IN SAID CITY.

Be it enacted by the Legislature of the State of Minnesota:

CHAPTER 1. SECTION 1. That the action of the common council of the city of Saint Paul, Minnesota, heretofore had in the matter of the vacation of streets and alleys in said city, which has received the approval of the mayor of said city, is hereby legalized, ratified and confirmed.

SEC. 2. This act shall take effect and be in force from and after its passage.

## CHAPTER 288.

[S. F. No. 360.]

AN ACT LEGALIZING THE VOTE OF THE VOTERS OF CHASKA INDE-PENDENT SCHOOL DISTRICT IN CARVER COUNTY, IN REGARD TO THE INSURANCE OF CERTAIN BONDS FOR THE PURPOSE OF ERECTING A SCHOOL BUILDING, AND THE ISSUE MADE THERE-UNDER, AND AUTHORIZING THE ISSUANCE THEREUNDER OF AD-DITIONAL BONDS BY SAID DISTRICT FOR SUCH PURPOSE.

Whereas, The question of the issuance of the bonds of Chaska Independent School District in the county of Carver, in the sum of nine thousand five hundred (9,500) dollars, for the purpose of erecting a school building for said district, was duly submitted to the legal voters of said district and the vote of said electors taken and properly canvassed, and declared to be carried in favor of the issuance of such bonds.

AND WHEREAS, Pursuant thereto, the bonds of said district in the sum of six thousand (6,000) dollars have been issued, and there remains unissued, of the amount thus authorized to be issued, the sum of three thousand five hundred (3,500) dollars. Therefore,

Be it enacted by the Legislature of the state of Minnesota:

Section 1. That all and singular, the acts and proceedings of said Chaska Independent school district and the board of education thereof, in submitting to the legal voters of said district the propositions in regard to the issuance of bonds for the purpose of building a school building for said district, as well as the canvass of the vote, and the making declaration thereof, and the issuance of bonds in pursuance thereof in the sum of six thousand (6,000) dollars, together with the manner, form and order of issuing the same and the mode of the execution thereof, be and the same are hereby legalized and made valid.

Sec. 2. The board of education of said district is hereby authorized to issue the bonds of said district under and pursuant to the vote of the electors of said district as so had and taken, in the additional sum of three thousand five hundred (3,500) dollars. Such bonds shall be executed in the same manner that the bonds of said district
