CHAPTER 293.

AN ACT TO CONFIRM AND, LEGALIZE CERTAIN ORDINANCES AND CONTRACTS BASED THEREON, OF THE CITY OF MINNEAPOLIS, CONCERNING A PUBLIC MARKET.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the ordinance passed by the common council of the city of Minneapolis, and approved January twenty-first (21st) eighteen hundred and eighty-seven (1887), (granting and extending to Harlow A. Gale, his associates, heirs, and assigns, the time within which to provide and furnish a public market to be known as the "Central Market" in said city, to and until the first (1st) day of June, A. D. one thousand eight hundred and eighty-eight (1888); Provided, That the site and plans for such market building be reported to the sity council of the city of Minneapolis, on or before June first (1st), A. D. one thousand eight hundred and eighty-seven (1887), and the provisions thereof together with the provisions of the former contract and ordinance therein mentioned and made a part thereof concerning the same,) and the contract provided therein be, and the same and all the provisions thereof and of each thereof, are hereby legalized and confirmed to the extent of the rights and privileges set forth therein, and the conditions of said ordinance and of such contract are made operative and binding upon the respective parties thereto.

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 294.

AN ACT TO LEGALIZE CERTAIN TAX ASSESSMENTS IN THE CITY OF ORTONVILLE, BIG STONE COUNTY, MINNESOTA.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That all assessments heretofore made during the years of one thousand eight hundred and eighty-three (1883), one thousand eight hundred and eighty-four (1884), one thousand eight hundred and eighty-five (1885) and one thousand eight hundred and eighty-six (1886) respectively, by the township assessor of the town-

ship of Ortonville in the county of Big Stone, [state of] Minnesota, of the property situated within the city limits of the city of Ortonville in said county, during said years, be and the same hereby is legalized and declared valid as though assessed by a duly appointed assessor of the said city of Ortonville.

SEC. 2. This act shall take effect and be in force from and after its passage and approval.

CHAPTER 295.

AN ACT TO LEGALIZE THE ACTION OF THE BOARD OF EDUCATION OF THE CITY OF SAINT PAUL IN EXECUTING A CEBTAIN DEED.

Be it enacted by the Legislature of the State of Minnesota. .

SECTION 1. That that certain deed dated the twenty-third (23d) day of April, A. D. one thousand eight hundred and eighty-three (1883) and executed by the Board of Education of the city of Saint Paul, of the county of Ramsey and state of Minnesota, as grantors, and signed and acknowledged for and on behalf of said board of education by Joseph Oppenheim as president and J. G. Donnelly as secretary of said board of education, to Isaiah B. St. Peter, as grantee, whereby the following pieces, parcels and lots of land, situate in said county of Ramsey and state of Minnesota, and described as lots numbered ten (10), eleven (11), twelve (12), thirteen (13)and fourteen (14) of block numbered three (3) of Bazille and Robert's addition to West Saint Paul, county and state aforesaid, were then and there sold and conveyed as aforesaid, which said deed was afterwards and on the fourteenth (14th) day of November, A. D. one thousand eight hundred and eighty-three (1883), and at the hour of two (2) o'clock P. M. duly recorded in book one hundred and twentytwo (122) of warranty deeds, page thirty-one (31), in the office of the register of deeds of said Ramsey county, be and the same is hereby legalized and made valid in all respects, and the acts of said board of education in selling said property and causing its said officers to execute said deed are hereby legalized and made valid in all respects.

SEC. 2. This act shall take effect and be in force from and after its passage.
