

CHAPTER 332.[S. F. No. 354.]^a

AN ACT TO FIX THE SALARY OF THE COUNTY ATTORNEY AND JUDGE OF PROBATE OF BELTRAMI COUNTY.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the salary of the county attorney of Beltrami county is hereby fixed at six hundred (600) dollars per annum.

SEC. 2. That the salary and compensation of the judge of probate of Beltrami county is hereby fixed at five hundred (500) dollars per annum.

SEC. 3. That the said salaries shall be payable monthly out of the revenue fund of said county.

SEC. 4. This act shall take effect and be in force from and after its passage.

CHAPTER 333.

[S. F. No. 303.]

AN ACT TO PROVIDE ADDITIONAL COMPENSATION TO THE AUDITOR AND ASSESSOR OF RAMSEY COUNTY, FOR CLERK HIRE DURING THE YEARS ONE THOUSAND EIGHT HUNDRED AND EIGHTY-SEVEN (1887) AND ONE THOUSAND EIGHT HUNDRED AND EIGHTY-EIGHT (1888), IN TRANSCRIBING THE BOOKS OF THEIR RESPECTIVE OFFICES, RENDERED NECESSARY BY REASON OF THE EXTENSION OF THE CITY LIMITS AND OTHER PURPOSES.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the auditor of Ramsey county for the two (2) years commencing on the first (1st) day of April, one thousand eight hundred and eighty-seven (1887), shall be paid the sum of twelve hundred (1,200) dollars for each year, as additional compensation for clerk hire, to be paid as other salaries, to transcribe the auditor's books so as to make them conform to the increased number of wards and the distribution of the several tax levies growing out of the extension of the city limits in one thousand eight hundred and eighty-five (1885), and one thousand eight hundred and eighty-seven (1887).

SEC. 2. That the assessor of Ramsey county for the years herein before named, for each of said years shall receive six hundred (600)

dollars, to be paid as hereinbefore named, for like services in his office as provided for in section one (1) of this act in relation to the auditor of said county.

SEC. 3. That section six (6) of "an act to amend the city charter of the city of Saint Paul and the acts amendatory thereof," approved February twenty-second (22d), one thousand eight hundred and eighty-seven (1887), is hereby amended by striking out the word "second" (2d), before the word Tuesday and inserting in lieu thereof the word "first" (1st).

SEC. 4. The jailor of the city of Saint Paul shall receive as compensation for his services nine hundred (900) dollars per annum.

SEC. 5. The market master of the city of Saint Paul shall receive as his compensation for his services, twelve hundred (1,200) dollars per annum.

SEC. 6. This act shall take effect* and be in force from and after its passage.

CHAPTER 334.

(S. F. No. 116.)

AN ACT FOR AN ACT ENTITLED, AN ACT TO REDUCE THE NUMBER OF COUNTY COMMISSIONERS IN THE COUNTY OF WASECA FROM SIX (6) TO FIVE (5), TO LIMIT THE COMPENSATION OF SUCH COUNTY COMMISSIONERS AND TO RE-ARRANGE THE COMMISSIONER DISTRICTS OF SAID COUNTY.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. The board of county commissioners of the county of Waseca shall be composed of five (5) members, one (1) of whom shall be chosen from each of the commissioner districts hereinafter provided for.

SEC. 2. Commissioner district number one (1) shall comprise the towns of Otises, New Richland and Byron, in said county.

SEC. 3. Commissioner district number two (2) shall comprise the city of Waseca, in said county.

SEC. 4. Commissioner district number three (3) shall comprise the towns of Woodville, Blooming Grove and Iosco in said county.

SEC. 5. Commissioner district number four (4) shall comprise the towns of St. Mary, Alton and Janesville, in said county.

SEC. 6. Commissioner district number five (5) shall comprise the towns of Freedom, Wilton and Vivian, in said county.

SEC. 7. The members of said board shall receive the same compensation as is now provided by law for the county commissioners of
