

CHAPTER 337.

[S. F. No. 340.]

AN ACT TO PROVIDE FOR TAXATION WITHIN THE CITY OF SHAKOPEE, FOR ROAD AND BRIDGE PURPOSES.

Be it enacted by the Legislature of the State of Minnesota

SECTION 1. The common council of the city of Shakopee is hereby authorized to levy a tax annually upon the real and personal property in said city for road and bridge purposes, not to exceed one (1) mill upon each dollar of assessed valuation, in addition to the taxes already authorized to be levied for that purpose, which tax may, if necessary, be in addition to and excess of the aggregate amount of taxation otherwise authorized to be levied by said common council; and no tax for road or bridge purposes shall hereafter be levied upon property in said city, except such as is levied therein by said common council.

SEC. 2. The moneys raised by the tax authorized to be levied by the foregoing section, shall be expended under the direction of said common council, in the construction, maintenance and repair of streets, alleys and bridges within said city and public highways leading thereto.

SEC. 3. The county treasurer of the county of Scott shall at each settlement hereafter made, set apart for said city and pay over to the treasurer of said city all taxes and moneys in the county treasury at the time of such settlement, levied and collected as taxes upon the real or personal property in said city for road or bridge purposes.

SEC. 4. This act shall take effect and be in force from and after its passage.

CHAPTER 338.

AN ACT TO PROHIBIT THE CATCHING FISH IN LAKE MINNEWASHTA, CARVER COUNTY, MINNESOTA.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That it shall be unlawful for any person to take, catch, kill or destroy in any manner whatever, any fish in lake Minnewashta, county of Carver, or in any inlet or outlet of said lake, between the first (1st) day of March and the fifteenth (15th) day of May, in any year, and after the said fifteenth (15th) day of May, only with hook and line, or spear.

SEC. 2. Any person who shall violate the provisions of this act shall be guilty of misdemeanor, and upon conviction thereof shall be punished by a fine of not less than ten (\$10) nor more than twenty-five (\$25) dollars, and be committed to the county jail until such fine and costs are paid; such commitment, however, not to exceed ten (10) days.

SEC. 3. All proceedings under this act shall be commenced within sixty (60) days from the time such offences were committed, and shall be brought in the same manner as provided by law in similar cases, and all fines imposed and collected under this act shall be paid into the treasury of said Carver county for the use of the public schools in said county.

SEC. 4. This act shall take effect and be in force from and after its passage.

CHAPTER 339.

AN ACT REGULATING THE COMPENSATION OF THE COUNTY COMMISSIONERS OF McLEOD COUNTY.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. The county commissioners of the county of McLeod shall each receive three dollars (\$3.00) per day for each day necessarily employed in the discharge of official duty and ten (10) cents per mile for every mile traveled in the performance of such duty, the mileage so traveled to be computed by the nearest traveled route; but no commissioner of said county shall receive pay for more than forty (40) days in any one (1) year.

SEC. 2. All acts or parts of acts inconsistent with the provisions of this act, so far as the same apply to the county of McLeod, be and the same are hereby repealed.

SEC. 3. This act shall take effect and be in force from and after its passage.
