Sec. 1. That part of Douglas county in the state of Minnesota included within the following described limits, descriptions and boundaries, to-wit: Lots two (2), three (3), four (4), five (5), six (6) and seven (7), of section numbered eighteen (18), all of section numbered nineteen (19), the north half ($\frac{1}{2}$) and the west half ($\frac{1}{2}$) of the southwest quarter ($\frac{1}{4}$) of section numbered twenty (20), the south half ($\frac{1}{2}$) of section numbered seventeen (17), the east half ($\frac{1}{2}$) of the northwest quarter ($\frac{1}{4}$) and the southwest quarter ($\frac{1}{4}$) and lots one (1), two (2), and three (3), of section numbered sixteen (16), lots numbered one (1), two (2), three (3) and four (4), and the northwest quarter ($\frac{1}{4}$) of the northwest quarter ($\frac{1}{4}$) of section numbered twenty-one (21); lots five (5) and six (6), and the east half ($\frac{1}{2}$) of the southwest quarter ($\frac{1}{4}$) of section numbered nine (9), all in township numbered one hundred and twenty-eight (128), north of range numbered thirty-seven (37) west. Also the east half ($\frac{1}{2}$) of the southeast quarter ($\frac{1}{4}$) of section numbered thirteen (13) and lots number one (1) and six (6), of section numbered twenty-four (24), all in township numbered one hundred and twenty-eight (128), north of range numbered thirty-eight (38), west, shall be a village by the name of the village of Alexandria and the people now inhabiting and those who shall hereafter inhabit the district of country herein described shall be a municipal corporation by the name of the village of Alexandria and shall have all the powers possessed by municipal corporations at common law and in addition thereto shall possess the powers specifically granted and the authorities thereof shall have perpetual succession, shall be capable of contracting and being contracted with, suing and being sued in all courts; may have a seal and change the same at pleasure and lease such real, personal and mixed estate within or without the limits thereof as the purposes of said village may require.

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 55.

AN ACT TO AMEND CHAPTER FORTY-SIX (46) OF THE SPECIAL LAWS OF ONE THOUSAND EIGHT HUNDRED AND EIGHTY-ONE (1881), ENTITLED "AN ACT TO INCORPORATE THE VILLAGE OF WADENA IN THE COUNTY OF WADENA."

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That chapter forty-six (46) of the special laws of one thousand eight hundred and eighty-one (1881), entitled "an act to

incorporate the village of Wadena in the county of Wadena", be and the same is hereby amended by adding to the end of section eight (8) of said chapter the following proviso, to wit:

Provided, That all taxes for road and bridge purposes shall be levied by the village council of said village, and the auditor of the county of Wadena shall draw his warrant on the county treasurer in favor of the village treasurer for all moneys now in the county treasury arising from delinquent road and bridge taxes collected in said village or which hereafter may be paid into the county treasury arising from delinquent road and bridge taxes collected in said village.

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 56.

AN ACT TO AMEND AN ACT ENTITLED "AN ACT TO AMEND AN ACT ENTITLED AN ACT TO INCORPORATE THE VILLAGE OF WADENA, IN THE COUNTY OF WADENA: APPROVED FEBRUARY FOURTEENTH, (14TH) A. D. ONE THOUSAND EIGHT HUNDRED AND EIGHTY-ONE. (1881)

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That section one (1) of chapter thirty (30) of the special laws of the year one thousand eight hundred and eighty-five (1885) be amended so as to read as follows: "That section one (1) of chapter forty-six (46) of the special laws of the year one thousand eight hundred and eighty-one, (1881), be amended by adding thereto the following: "*Provided*, that the following described territory be annexed to and made a part of said village, subject to the conditions of said chapter forty-six, (46), viz: The east half ($\frac{1}{2}$) and northwest quarter ($\frac{1}{4}$) of section numbered five, (5), the west half ($\frac{1}{2}$) and northeast quarter ($\frac{1}{4}$) of section numbered six, (6), the west half ($\frac{1}{2}$) and the southeast quarter ($\frac{1}{4}$) of section numbered seven, (7), and the east half ($\frac{1}{2}$) and southwest quarter ($\frac{1}{4}$) of section numbered eight (8), all in township numbered one hundred and thirty-four (134) north, of range numbered thirty-five, (35), west of the fifth (5th) principal meridian, in the county of Wadena and state of Minnesota.

SEC. 2. This act shall take effect and be in force from and after its passage.
