

## CHAPTER 318.

[H. F. No. 474.]

AN ACT TO AUTHORIZE THE BOARD OF COUNTY COMMISSIONERS OF WASHINGTON COUNTY TO LEVY A TAX FOR ROADS AND BRIDGES.

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. The board of county commissioners of Washington county are hereby authorized at their regular meeting in July of each year to levy a tax for road and bridge purposes in said county, to be used under and by their directions in an amount not exceeding five thousand (5,000) dollars in any one year.

SEC. 2. This act shall take effect and be in force from and after its passage.

## CHAPTER 319.

[S. F. NO. 484.]

AN ACT TO AUTHORIZE THE VILLAGE COUNCIL OF THE VILLAGE OF SAUK RAPIDS IN THE COUNTY OF BENTON, TO APPROPRIATE MONEY FOR THE PURPOSE OF AIDING IN SECURING AND PAYING FOR RIGHT OF WAY FOR A SPUR TRACK OF THE SAINT PAUL AND NORTHERN PACIFIC RAILROAD COMPANY THROUGH THE VILLAGE OF SAUK RAPIDS.

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. That the village council of the village of Sauk Rapids in the county of Benton, is hereby authorized and empowered to appropriate a sum not to exceed fifteen hundred (1,500) dollars out of the village treasury of said village of Sauk Rapids, to be used and expended by said village council for the purpose of aiding in the securing and paying for railroad purposes, the right of way over certain lands and lots situated in said village of Sauk Rapids upon, over and across which that branch or spur track of the Saint Paul and Northern Pacific Railroad Company (a corporation) generally known as the "spur track of the said Saint Paul and Northern Pacific Railroad Company from Sauk Rapids to Moody's quarry" is now located and operated through said village of Sauk Rapids.

SEC. 2. The money authorized to be appropriated by said village council of said village of Sauk Rapids as provided by section one (1) of this act shall be expended and paid out under the direction of said

village council in such manner and at such times as said village council may direct.

SEC. 3. This act shall take effect and be in force from and after its passage.

## CHAPTER 320:

[S. F. No. 491.]

**AN ACT TO AUTHORIZE THE COUNTY COMMISSIONERS OF BECKER COUNTY TO CAUSE CERTAIN MEANDERED LAKES, AND OVERFLOWED LANDS BORDERING ON SAID LAKES IN SAID COUNTY TO BE DRAINED.**

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. The county commissioners of Becker county in this state, are hereby authorized and empowered, to cause the meandered lake lying in sections ten (10), eleven (11), fourteen (14), fifteen (15), twenty-one (21) and twenty-two (22), in township one hundred and forty (140), of range forty-two (42), in said county; and the meandered lake lying in sections twenty-six (26), twenty-seven (27), thirty-four (34) and thirty-five (35), in said township and county; and the overflowed marshes and meadow lands bordering on said lakes, to be drained by widening, deepening and straightening the outlet of said lakes, and of each of them, for such distance along said outlet in said township, in said county, as may be deemed expedient and necessary; and to apportion the benefits and damages and expenses incident thereto; and to collect and pay for the same; and to do all acts in relation thereto, in accordance with the provisions of chapter ninety-seven of the general statutes of eighteen hundred and eighty-seven (1887), and acts amendatory thereof, any act or acts to the contrary notwithstanding.

SEC. 2. This act shall take effect and be in force from and after its passage.
