CHAPTER 346.

AN ACT TO AUTHORIZE THE COUNTY COMMISSIONERS OF HENNEPIN COUNTY TO ALLOW AND APPROPRIATE SUFFICIENT MONEY TO PAY CERTAIN FEES AND COSTS INCURRED IN THE SERVICE AND RETURN OF DELINQUENT PERSONAL PROPERTY TAX WARRANTS IN SAID COUNTY AND TO LEGALIZE THE SAME.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. The county commissioners of the county of Hennepin are hereby authorized to audit, allow and appropriate fifteen hundred (1,500) dollars to pay the sheriff fees and mileage for the service and return of warrants issued to him by the clerk of the district court of said county for the collection of delinquent personal property taxes in the year eighteen hundred and eighty-seven (1887), which still remain unpaid, such sum to be in full compensation for all services performed in the collection of such delinquent taxes.

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 347.

AN ACT ENTIFILED AN ACT TO EMPOWER THE BOARD OF COUNTY COMMISSIONERS OF FREEBORN COUNTY, MINNESOTA, TO REIM-BURSE THE BONDSMEN OF THOMAS F. McCORMICK FOR SUCH SUMS AS THEY MAY HAVE EXPENDED IN ADDITION TO THE AMOUNT RECEIVED BY SAID THOMAS F. McCORMICK IN COM-PLETING HIS CONTRACT FOR THE ERECTION OF A PORTION OF THE COURT HOUSE IN THE CITY OF ALBERT LEA.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the county commissioners of the county of Freeborn, Minnesota, are hereby authorized and empowered in their discretion to pay to the bondsmen of Thomas F. McCormick, one of the contractors for the erection of a court house in the city of Albert Lea, such sum as said bondsmen have actually expended in the completion of said court house under said Thomas F. McCormick's contract, which said contract bears date the twenty-third (23d) day of March, A. D. eighteen hundred and eighty-seven (1887), in excess of the amount to be received by said Thomas F. McCormick, as specified in said contract.

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 348.

AN ACT TO ALLOW PUBLIC ENTERTAINMENTS TO BE GIVEN AT THE CLUB HOUSE AND GYMNASIUM OF THE TURN VEREIN GER-MANIA OF THE CITY OF SAINT PAUL.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That permission is hereby granted for the giving of concerts, theatrical performances and public entertainments at the club house and gymnasium of the Turn Verein Germania, on Franklin street, in the city of Saint Paul. *Provided, however*, that such measures be or have been adopted by said society for the safety of the public as the building inspector of the city of Saint Paul may deem necessary.

And provided, further, that chapter three hundred and fifteen (315) of the special laws of Minnesota of eighteen hundred and eightyseven (1887), relating to the construction of public buildings in the city of Saint Paul, does not apply to said club house and gymnasium of said Turn Verein Germania.

SEC. 2. This act shall take effect and be in force from and after its passage.

AN ACT TO REGULATE AND FIX THE COMPENSATION OF THE COUNTY AUDITOR AND COUNTY TREASURER OF SAINT LOUIS COUNTY AND CLERK HIRE FOR THE SAME.

Be it enacted by the Legislature of the State of Minnesota;

SECTION 1. The compensation of the county treasurer and county auditor of the county of Saint Louis in this state be and the same is hereby fixed and established as follows: The county treasurer shall
