

## CHAPTER 426.

[H. F. No. 914.]

## AN ACT TO ESTABLISH THE TOWN OF ORONO, IN HENNEPIN COUNTY.

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. That so much of the town of Medina, Hennepin county, Minnesota, as is embraced in the following described limits be, and the same is hereby, erected and created into a separate town, to be known as the town of Orono, to-wit: Beginning at the north-east corner of section two (2), township one hundred and seventeen (117), range twenty-three (23); thence running east on the north line of section one (1) in said township and range to the southeast corner of section thirty-six (36), township one hundred and eighteen (118), range twenty-three; thence north on said east line of said section thirty-six (36) and on the east line of section twenty-five (25) in said township and range, to the east and west center line of said section twenty-five (25), thence west on the east and west center lines of sections twenty-five (25), twenty-six (26), twenty-seven (27), twenty-eight (28), twenty-nine (29) and thirty (30) of said township one hundred and eighteen (118), range twenty-three (23), to the west line of Medina township, as now established; thence south on said west line of Medina township to the south line of said township; thence in an easterly direction on the said south line of said Medina township, to the east line of said township; thence north on said east line of said township to the place of beginning.

SEC. 2. The first election for officers of the town of Orono shall be held at the town hall in the village of Long Lake, Minnesota, on the second (2d) Tuesday of April, A. D., one thousand eight hundred and eighty-nine (1889); and written notices of the time and place of holding said election, signed by five (5) legal voters residing within the limits of said township of Orono shall be posted in three (3) of the most public places within the limits of said town of Orono at least ten (10) days previous to the time of said election.

SEC. 3. The electors residing within the limits of said town of Orono, when assembled in accordance with such notice, shall have and possess all the powers conferred upon electors at annual township elections; and the said election shall be opened and conducted in all respects as the said annual township elections; and the judges of said election shall issue certificates of election to the persons legally entitled to the same, who shall hold office until the annual township election to be held on the second (2d) Tuesday of March, one thousand eight hundred and ninety (1890).

SEC. 4. The township officers of said township of Medina and of said township of Orono shall proceed as soon as possible after the passage of this act to sell all of the real and personal property belonging to the present township of Medina; and shall pay one-half ( $\frac{1}{2}$ ) of the proceeds of said sale to the treasurer of said township of Me-

dina and one-half ( $\frac{1}{2}$ ) thereof to the treasurer of said township of Orono.

SEC. 5. This act shall take effect and be in force from and after its passage.

## CHAPTER 427.

AN ACT TO FIX THE SALARY OF THE PROBATE JUDGE OF THE COUNTY OF MILLE LACS.

*Be it enacted by the Legislature of the State of Minnesota :*

SECTION 1. That the salary of the probate judge of the county of Mille Lacs, be, and the same is hereby fixed at the sum of four hundred dollars (\$400) per annum, payable as the salaries of other county officers are now paid.

SEC. 2. This act shall take effect and be in force from and after its passage.

## CHAPTER 428.

AN ACT TO AMEND CHAPTER ONE HUNDRED AND TWELVE (112) OF THE SPECIAL LAWS OF MINNESOTA FOR THE YEAR ONE THOUSAND EIGHT HUNDRED AND EIGHTY-SEVEN (1887), ENTITLED "AN ACT TO AMEND SECTIONS ONE (1) AND TWO (2) OF CHAPTER ONE HUNDRED AND THIRTEEN (113) OF THE SPECIAL LAWS OF MINNESOTA FOR THE YEAR ONE THOUSAND EIGHT HUNDRED AND EIGHTY-FIVE (1885) RELATING TO THE APPOINTMENT OF A PHONOGRAPHIC REPORTER FOR THE DISTRICT COURT OF THE COUNTY OF HENNEPIN."

*Be it enacted by the Legislature of the State of Minnesota :*

SECTION 1. That chapter one hundred and twelve (112) of the special laws of Minnesota for the year one thousand eight hundred and eighty-seven (1887) be, and the same is hereby amended so as to read as follows:
