

CHAPTER 458.

[S. F. No. 847.]

AN ACT TO REGULATE THE CATCHING OF FISH IN EAGLE LAKE,
KANDIYOHI COUNTY.*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. It shall be unlawful for any person or persons to catch or destroy any fish with seines, dip nets, or gill nets in Eagle Lake, Kandiyohi county, Minnesota, at any time.

SEC. 2. Any person or persons violating any of the provisions of the preceding section of this act, shall be guilty of a misdemeanor, and upon conviction thereof shall suffer and pay a fine of not less than ten (10) dollars nor more than fifty (50) dollars and costs of prosecution, and in default of the payment of such fine and costs, shall be committed to the county jail for a term of not less than ten (10) days nor more than thirty (30) days for each and every offense.

SEC. 3. All prosecutions under the provisions of this act shall be commenced by complaint, under oath, within sixty (60) days from the time the offense was committed, and all fines collected under the provisions of this act shall be paid into the county common school fund of said Kandiyohi county.

SEC. 4. Suits may be commenced and prosecuted by any person having knowledge of violation of this act, before any justice of the peace in said Kandiyohi county.

SEC. 5. This act shall take effect and be in force from and after its passage.

CHAPTER 459.

[S. F. No. 338.]

AN ACT ENTITLED AN ACT TO PREVENT THE DESTRUCTION OF
FISH IN THE WATERS OF OTTER TAIL COUNTY.*Be it enacted by the Legislature of the State of Minnesota.*

SECTION 1. No person shall at any time take, catch or kill any fish of any kind, except sturgeon, from or in any of the waters of the county of Otter Tail, in this state, in any other manner than by angling for them with a hook and line; *provided*, that it shall be lawful for any person to take all kinds of fish in said waters by fishing for the same with nets before the first (1st) day of March and after the thirtieth (30th) day of September, in any year; and *provided*, that it

shall be lawful for any person at any time to take all kinds of fish in said waters in any other manner than by nets or seines, for private use as food for said person or his family.

SEC. 2. No person or corporation, or any employe of such corporation shall at any time or in any manner export or carry out or cause to be exported or carried out, or have in possession for the purpose of carrying out, or attempt in any way to carry out of the limits of said county any fish except sturgeon.

SEC. 3. Any person or persons violating any of the provisions of this act shall be guilty of a misdemeanor, and upon conviction thereof shall be punished by a fine of not less than ten (10) dollars or more than fifty (50) dollars and costs of prosecution.

SEC. 4. It shall be the duty of supervisors and constables of towns, the trustees and marshals of incorporated villages, and all others residing or being within said county, having knowledge of the violation of any of the provisions of this act, to make complaint thereof to any justice of the peace within said county; and such justice shall thereupon issue his warrant for the arrest of the offender, and shall upon the arrest of such offender and the return of such warrant, proceed to hear and determine the matter in issue in the same manner as in other cases, and every person convicted of the violation of any of the provisions of this act shall stand committed until his fine is paid; *provided*, that such imprisonment shall not exceed sixty (60) days; and *provided*, that if any corporation shall be a defendant, the process shall be served and the penalty recovered as in civil actions.

SEC. 5. All acts and parts of acts inconsistent herewith are hereby repealed.

SEC. 6. This act shall take effect and be in force from and after its passage.

CHAPTER 460.

[H. F. No. 725.]

AN ACT REGULATING THE CATCHING OF FISH IN CERTAIN LAKES IN MEEKER AND WRIGHT COUNTIES.

Be it enacted by the Legislature of the State of Minnesota :

SECTION 1. It shall be unlawful hereafter for any person to catch, kill or destroy in any manner whatever, any fish in Lake Mannuella Lake Stella, Lake Washington in Meeker county and Lake Collinwood in Meeker and Wright counties, between the first (1st) day of December and the first (1st) day of April of any year.

SEC. 2. Any person or persons violating any of the provisions of the preceding section shall be guilty of a misdemeanor and upon con-
