

ber three (3) of Dakota county, and, as such school district under the name and style aforesaid, to have and enjoy all the powers and rights and be subject to all the duties of a common school district organized under the general laws of this state.

SEC. 2. The legal voters within the limits of said district, within twenty (20) days after the passage and approval of this act, shall meet at the school house now within the said limits, and elect a director, treasurer and clerk of said district, and the officers so elected shall immediately qualify, and the clerk shall thereupon and at once notify the proper officers of said county of Dakota of said election; *provided*, a notice of the time and place of said meeting, signed by any three (3) of the legal voters, being freeholders or householders residing within the limits of said district, shall be given in the manner now prescribed by law for the election of officers in new districts.

SEC. 3. All school taxes levied in the year one thousand eight hundred and eighty-eight (1888) by the city of South Saint Paul on persons and all property within the limits of this district shall be paid to the proper officer of said district by the county officers at the usual times of settlement and payment of school taxes, and the general school taxes shall be paid to said district in the same manner.

SEC. 4. The county superintendent of the county of Dakota shall have jurisdiction over said district and visit the same, and grant certificates to teach therein as in other cases.

SEC. 5. This act shall take effect and be in force from and after its passage.

CHAPTER 502.

AN ACT TO AMEND AN ACT ENTITLED "AN ACT TO CREATE A SCHOOL DISTRICT OUT OF CERTAIN TERRITORY LYING IN THE TOWN OF INVER GROVE IN THE COUNTY OF DAKOTA, AND CONCERNING TAXES RELATING THERETO," APPROVED MARCH TWELFTH (12TH) EIGHTEEN HUNDRED AND EIGHTY-NINE (1889).

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That section three (3) of an act entitled "An act to create a school district out of certain territory lying in the town of Inver Grove in the county of Dakota, and concerning taxes relating thereto," approved March twelfth (12th), A. D. eighteen hundred and eighty-nine (1889), be and the same is hereby amended by adding at the end of said section the following words, to-wit: The county treasurer, upon the order of the county auditor, shall pay to the treasurer of said district, or to his written order, such part of all moneys now ap-

portioned to the school district to which said district number three (3) bears to the total assessed valuation of all the property in the district from which said district number three (3) was detached and at and prior to the passage of the act hereby amended; said order to be drawn as aforesaid as soon as the said moneys come into the hands of said treasurer.

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 503.

AN ACT TO ANNEX COMMON SCHOOL DISTRICT NUMBER FIFTY-THREE (53) AND A PORTION OF COMMON SCHOOL DISTRICT NUMBER THIRTY-THREE (33), IN WASHINGTON COUNTY, TO COMMON SCHOOL DISTRICT NUMBER THIRTY-SIX (36) IN SAID WASHINGTON COUNTY.

Be it enacted by the Legislature of the State of Minnesota :

SECTION 1. That the following lands now comprising common school district number fifty-three (53) in Washington county, namely: The southeast quarter ($se\frac{1}{4}$) of section thirty-one (31) in town twenty-eight (28), range twenty-two (22), and the east half ($e\frac{1}{2}$) of section six (6); the south half ($s\frac{1}{2}$) of the southwest quarter ($sw\frac{1}{4}$) of section six (6), the west half ($w\frac{1}{2}$) of the west half ($w\frac{1}{4}$) of section five (5), the south half ($s\frac{1}{2}$) of the south half ($s\frac{1}{4}$) of section five (5); the whole of section seven (7), eight (8) and eighteen (18), all of which said lands are in town twenty-seven (27), range twenty-two (22) in Washington county, be and the same are hereby attached to and made part of common school district number thirty-six (36) of said Washington county. And also that the south half ($s\frac{1}{2}$) of section twelve (12) and that portion of the southeast quarter ($se\frac{1}{4}$) of section eleven (11), east of the Mississippi river; the whole of section thirteen (13) and that portion of section fourteen (14) east of the Mississippi river, all of which said lands are in town twenty-seven (26), range twenty-two (22) in Washington county, be and the same are hereby detached from common school district number thirty-three (33) in Washington county, and attached to and made part of common school district number thirty-six (36) of said Washington county, changing thereby the boundaries of said common school district number thirty-six (36) in said Washington county to include the said lands.

SEC. 2. This act shall take effect and be in force from and after its passage.
