

CHAPTER 504.

[S. F. No. 520.]

AN ACT TO DIVIDE SCHOOL DISTRICT NUMBER TWENTY-FIVE (25) IN YELLOW MEDICINE COUNTY, AND TO PROVIDE FOR A DIVISION OF ITS PROPERTY AND THE PAYMENT OF ITS DEBTS.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That school district number twenty-five (25) in the county of Yellow Medicine which comprises the entire township number one hundred and fourteen (114) north, of range number forty-two (42) in said county is hereby divided into two (2) separate school districts. The east eighteen (18) sections of said township are hereby established and shall hereafter constitute and be known as school district number twenty-five (25) in the county of Yellow Medicine and the west eighteen (18) sections in said township are hereby established and shall hereafter constitute and be known as school district number sixty-seven (67) in Yellow Medicine county.

SEC. 2. Each of said new districts shall have and retain the school houses and other school property now situated within its limits but all moneys now belonging to said old district, whether the same have been or shall hereafter be collected shall be divided between and belong equally to each of said new districts.

SEC. 3. The bonded indebtedness of said old school district amounting to fifteen hundred dollars (\$1500.00) and all other debts heretofore contracted or incurred shall be borne and paid equally by each of said new districts.

SEC. 4. This act shall take effect and be in force from and after its passage.

CHAPTER 505.

AN ACT RELATING TO THE CLERKSHIP OF THE BOARD OF EDUCATION OF THE INDEPENDENT SCHOOL DISTRICT OF DULUTH.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. Any proper person, whether a member of the board of education of the independent school district of Duluth, or not, may be chosen clerk of said board, with all the powers and duties attendant upon said office as prescribed by law; and any person so chosen

shall, before entering upon the discharge of his duties as such clerk, give bonds for the faithful performance of his official duties, in such amount as said board of education may require.

SEC. 2. All acts and parts of acts inconsistent with this act, are hereby repealed.

SEC. 3. This act shall take effect and be in force from and after its passage.

CHAPTER 506.

AN ACT TO CREATE A NEW SCHOOL DISTRICT IN HENNEPIN COUNTY, MINNESOTA.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the following described tracts of land situate in Hennepin county, Minnesota, viz: All of sections one (1), six (6) and twelve (12), and all of sections five (5), seven (7), eight (8), thirteen (13), eighteen (18) and twenty-four (24) lying west of the Minnesota river, all in township twenty-seven (27) of range twenty-three (23), the south half ($\frac{1}{2}$) of the southeast quarter ($\frac{1}{4}$) of section thirty-six (36) in township twenty-eight (28) of range twenty-four (24, the south half ($\frac{1}{2}$) of the southwest quarter ($\frac{1}{4}$) of section thirty-one (31), the south half ($\frac{1}{2}$) of the southeast quarter ($\frac{1}{4}$) of section thirty-one (31) and the south half ($\frac{1}{2}$) of the south-west quarter ($\frac{1}{4}$) of section thirty-two (32) in township twenty-eight (28) of range twenty-three (23) be and the same are hereby constituted a school district for all common school purposes, whatsoever, said new school district to be numbered hereafter by the county auditor of said Hennepin county.

SEC. 2. All acts and parts of acts inconsistent herewith are hereby repealed.

SEC. 3. This act shall take effect and be in force from and after its passage.
