

## CHAPTER 565.

[H. F. No. 685.]

AN ACT LEGALIZING THE ACTIONS OF THE TOWN COUNCIL OF THE TOWN OF TAYLOR FALLS, CHISAGO COUNTY, IN OPENING AND GRADING CHESTNUT AND MAPLE STREETS IN SAID TOWN.

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. That the actions of the town council of the town of Taylor Falls, Chisago county, in the opening and grading of Chestnut and Maple streets in said town in the year one thousand eight hundred and eighty-five (1885), be and the same is legalized, and the town council of said city is hereby authorized to pay for the work done in opening and grading said streets in said year an amount not to exceed three hundred and sixty (360) dollars out of the town funds of said town.

SEC. 2. This act shall take effect and be in force from and after its passage.

## CHAPTER 566.

[H. F. No. 772.]

AN ACT TO LEGALIZE THE PLAT OF THE TOWN SITE OF DULUTH IN SAINT LOUIS COUNTY, AND AUTHORIZING A RESURVEY THEREOF.

*Be it enacted by the Legislature of the State of Minnesota:*

WHEREAS, the original survey and plat thereof of the town of Duluth, which was filed for record in the office of the register of deeds of Saint Louis county, on the twenty-ninth (29th) day of May eighteen hundred and fifty-six (1856), and afterwards recorded in book "A" of plats, on pages nine (9) and ten (10), shows no monument referred to by said survey and the certificate of the surveyor who made the same, and does not upon its face fully identify the tract or tracts of land covered or intended to be covered thereby; and

WHEREAS, the land embraced or intended to be, within said plat, is located in part within the limits of the village of Park Point, in the county of Saint Louis, and in part within the limits of the city of Duluth, in said county;

Now, THEREFORE, be it enacted:

SECTION 1. That said plat of the town of Duluth is hereby legal-

ized and confirmed, to the same extent and with the same effect as if the same had been in all respects properly made, executed, certified and filed for record.

SEC. 2. The county commissioners of the county of Saint Louis are hereby authorized and directed to cause a resurvey of the land embraced within said plat, to be made by the county surveyor of said Saint Louis county, who shall ascertain from the best evidence obtainable, the location of the monuments referred to in said original survey and the certificate of the surveyor who made the same, and the location of said plat with reference to the lines of the United States government survey on or adjacent thereto, and the external boundaries thereof, and such other facts as may be deemed essential to a full and clear description of the location of said plat and the streets and avenues appearing thereon; and shall also cause at least four granite monuments to be placed upon the land embraced within said plat at points to be by him selected and described, from which future surveys may be made.

SEC. 3. Said county surveyor shall make a full and accurate report in writing to the county commissioners of the county of Saint Louis, of the resurvey herein authorized, and of the matters referred to in the first section of this act, with all reasonable despatch.

SEC. 4. Upon the presentation of said report, the county commissioners of said Saint Louis county shall cause the same to be filed for record with the register of deeds of Saint Louis county, who shall record the same at length, and note upon the record of the plat of the town of Duluth aforesaid the fact of the filing and recording of such report, and the book and page where the same is recorded, and such report or the record thereof shall, together with the recorded plat of said town of Duluth, be *prima facie* evidence in all cases of the land covered by said plat and of the truth of the matters in said report contained. The register of deeds shall receive the same fees for filing and recording said report as are now by law provided for filing and recording written instruments.

SEC. 5. The cost of such resurvey and report, and of recording the same, shall be paid by the county of Saint Louis.

SEC. 6. This act shall take effect and be in force from and after its passage.
