

**CHAPTER 581.**

[H. F. No. 397.]

AN ACT TO ENABLE THE CITY OF SAINT PAUL TO ISSUE BONDS FOR THE ERECTION OF A PUBLIC LIBRARY BUILDING.

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. That to provide means for the erection of a fire-proof public library building, the common council of the city of St. Paul are hereby authorized and empowered to issue and negotiate bonds of the city of St. Paul, as follows: Fifty thousand dollars (\$50,000), or as much thereof as may be required for the purchase of a site for a public library building. Said bonds shall be in denominations of one thousand dollars (\$1000) each, with coupons attached, and shall be payable in thirty (30) years from their date with interest not to exceed five (5) per cent per annum, payable semi-annually at the financial agency of the city of St. Paul, in the city of New York. The proceeds of said bonds shall be paid into the city treasury to the credit of the board of directors of the public library, and shall constitute a fund to be called the library fund.

SEC. 2. This act shall take effect from and after its passage.

**CHAPTER 582.**

[H. F. No. 674.]

AN ACT REGULATING THE TIMES AND MANNER OF CATCHING FISH IN CARVER COUNTY IN THIS STATE.

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. No person shall take, catch or kill any fish in any of the lakes, or the inlets or outlets thereof, of Carver county in this state, by the use of a spear or any instrument used in lieu thereof as a spear.

SEC. 2. It shall be unlawful to take, catch or kill any species of fish in said lakes and their said inlets and outlets between the first (1st) day of December and the fifteenth (15th) day of May following thereafter, in each and every year, and only with hook and line thereafter.

SEC. 3. Any person violating any of the provisions of this act is guilty of a misdemeanor, and upon conviction thereof shall be punished by a fine of not less than one (1) dollar nor more than five (5)

dollars for each and every offense, or in default, by imprisonment in the county jail for not more than thirty (30) days.

SEC. 4. All acts and parts of acts inconsistent with this act are hereby repealed, so far as they apply to said Carver county.

SEC. 5. This act shall take effect and be in force from and after the date of its passage.

## CHAPTER 583.

AN ACT TO AMEND AN ACT OF THE LEGISLATURE OF THE STATE OF MINNESOTA FOR THE YEAR EIGHTEEN HUNDRED AND EIGHTY-NINE (1889), ENTITLED "AN ACT TO AUTHORIZE THE BOARD OF COUNTY COMMISSIONERS OF BLUE EARTH COUNTY, TO PAY THE LICENSE MONEY COLLECTED FROM THE SALE OF INTOXICATING LIQUORS IN THE VILLAGE OF HILTON TO THE TREASURER OF SCHOOL DISTRICT NUMBER ONE HUNDRED AND FORTY-SIX (146) IN SAID COUNTY. APPROVED FEBRUARY ELEVENTH (11TH), ONE THOUSAND EIGHT HUNDRED AND EIGHTY NINE (1889)."

*Be it enacted by the Legislature of the State of Minnesota :*

SECTION 1. Section two (2) of an act entitled "an act to authorize the board of county commissioners of Blue Earth county to pay the license money collected from the sale of intoxicating liquors in the village of Hilton to the treasurer of school district number one hundred and forty-six (146) of said county, approved February eleventh (11th), one thousand eight hundred and eighty-nine (1889)," is hereby amended by adding at the end of said section two (2) the following: "*Provided*, all the provisions of this act shall apply to all license money received and collected in said village during any portion of the year eighteen hundred and eighty-nine (1889)."

SEC. 2. This act shall take effect and be in force from and after the date of its passage.
