

(1887), shall hereafter consist of twelve (12) members, and George A. Brackett, Edgar F. Comstock and Edward M. Johnson, electors and residents of said Hennepin county, are hereby appointed such additional members of said board. Such additional members shall take the oath prescribed in and by section three (3) of said act, and shall thereupon be deemed members of said board in all respects as though originally appointed by the terms of said act.

SEC. 2. That section two (2) of said act be and the same is hereby amended by striking out all of said section after the word "provided," in the twelfth (12th) line thereof, as the same is printed in the official volume of the special laws of this state for the year one thousand eight hundred and eighty-seven (1887), and inserting in lieu thereof the following, viz :

"And in case of a vacancy occurring in said board of court house and city hall commissioners, the same shall be filled by the remaining members of said board, by ballot from among the electors of said Hennepin county, *provided*, that no person shall be elected to fill such vacancy without first having received the ballots of the majority of the whole board.

And the person or persons so appointed, upon taking the oath prescribed in and by section three (3) of this act, shall be deemed members of said board in all respects as though originally appointed by the terms of said act. No member of said board shall receive any compensation for his services, nor shall any member of said board of court house and city hall commissioners be or become a party interested directly or indirectly in any contract made by said board or under its authority."

SEC. 3. This act shall take effect and be in force from and after its passage.

CHAPTER 63.

AN ACT TO AMEND CHAPTER SEVENTEEN (17) OF THE SPECIAL LAWS OF ONE THOUSAND EIGHT HUNDRED AND EIGHTY-ONE (1881) ENTITLED "AN ACT TO INCORPORATE THE VILLAGE OF GLENWOOD, IN POPE COUNTY, MINNESOTA."

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That section one (1) of chapter seventeen (17) of the special laws of one thousand eight hundred and eighty-one (1881) be and the same hereby is amended by adding after the words and figures thirty-seven (37) where they occur in the tenth (10th) line of said section, the following described territory, to wit: and the southeast quarter of the northeast quarter (s. e. $\frac{1}{4}$ of the n. e. $\frac{1}{4}$) of section one

(1), township one hundred and twenty-five (125), range thirty-eight (38), and the south half of the northwest quarter, and the south half of the northeast quarter (s. $\frac{1}{2}$ of the n. w. $\frac{1}{4}$ and s. $\frac{1}{2}$ of the n. e. $\frac{1}{4}$), and the southeast quarter (s. e. $\frac{1}{4}$) of section six (6) and the northeast quarter and the north one-half of the southeast quarter (n. e. $\frac{1}{4}$ and the n. $\frac{1}{2}$ of the s. e. $\frac{1}{2}$) of section seven (7) in township one hundred and twenty-five (125), range thirty seven (37), in Pope county, state of Minnesota, is hereby set apart and incorporated as the village of Glenwood, under the provisions of chapter one hundred and thirty-nine (139) of the general laws of the state of Minnesota for the year one thousand eight hundred and seventy-five (1875) and the amendments thereto.

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 64.

AN ACT TO AMEND AN ACT ENTITLED "AN ACT IN RELATION TO THE ERECTION OF PUBLIC BUILDINGS FOR THE USE OF THE CITY OF SAINT PAUL AND THE COUNTY OF RAMSEY, UPON BLOCK TWENTY (20), OF SAINT PAUL PROPER, KNOWN AS THE COURT HOUSE SQUARE, IN THE SAID CITY OF SAINT PAUL."

Be it enacted by the Legislature of the State of Minnesota.

SECTION 1. That section six (6) of an act entitled "an act in relation to the erection of public buildings for the use of the city of Saint Paul and the county of Ramsey, upon block twenty (20) of Saint Paul proper, known as the court house square, in the said city of Saint Paul," being chapter three hundred and seventy-six (376) of the special laws of the state of Minnesota for the year eighteen hundred and eighty-one (1881), approved March eight (8), eighteen hundred and eighty-one (1881), be and the same hereby is amended so as to read as follows:

Section 6. When said work or materials, or any part thereof, shall be placed under contract, the said city of Saint Paul and county of Ramsey shall hold the land occupied and needed for said building, together with the building which may be thereon erected, in common and for the public uses aforesaid; and the said board of county commissioners of said county of Ramsey is hereby empowered and required to convey to the said city of Saint Paul an undivided one-half ($\frac{1}{2}$) of all the estate, right, title and interest of said county in and to so much of said land as may be occupied and needed by said building. The said building when completed shall be in charge of a joint
