# CHAPTER 139.

#### [H. F. No. 39.]

### AN ACT TO DETACH LAKE COUNTY FROM ST. LOUIS COUN- Eleventh in-TY, AND TO ORGANIZE SAID LAKE COUNTY FOR JUDI- dicial district. CIAL PURPOSES.

#### Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. The county of Lake, heretofore attached to Lake county dethe county of St. Louis for judicial puposes, is hereby declared detached from said county of St. Louis and organized Louis county. for judicial purposes.

Term of the district court shall be held in said Terms of court SEC. 2. Lake county at a time to be fixed by the judge or judges of in Lake county. the Eleventh (11th) judicial district; and it shall be the duty of such judge, when in his opinion it is necessary to hold a general term of the district court in said county, to give at least forty (40) days' notice of the time when such general term shall be held, by publishing or causing to be published in some newspaper published in said county-if any there be, if not, then in an adjoining county-a notice that such term will be held; and such term or terms shall be held and deemed to be general terms of said district court as fully and to all intents as though the time of holding the same had been designated by an act of the legislature.

SEC. 3. All acts and parts of acts conflicting with the provisions of this act are hereby repealed.

SEC. 4. This act shall take effect and be in force from and after its passage.

### CHAPTER 140.

[H. F. No. 629.]

#### AN ACT TO CHANGE THE TIME FOR HOLDING THE GEN- Twenth judicial district. ERAL TERMS OF THE DISTRICT COURT IN THE SEVERAL COUNTIES OF THE TWELFTH (12TH) JUDICIAL DISTRICT.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. The general terms of the district court shall hereafter be held in the several counties comprising the Twelfth (12th) judicial district as follows:

In the county of Chippewa, on the first (1st) Monday after the first (1st) Tuesday in May, and the first (1st) Mon- Chipper county. day after the second (2d) Tuesday in November of each year.

Terms of court,

Chippewa

Lac qui Parle county.

Kandiyohi county.

Meeker county.

Swift county.

Yellow Medicine county In the county of Lac qui Parle, on the first (1st) Tuesday in May and the fourth (4th) Tuesday in October of each year.

In the county of Kandiyohi, on the first (1st) Tuesday in June and the second (2d) Tuesday in December of each year.

In the county of Meeker, on the third (3d) Tuesday in May and the second (2d) Tuesday in November of each year.

In the county of Swift, on the fourth (4th) Tuesday in June and the third (3d) Tuesday in December of each year. In the county of Yellow Medicine, on the third (3d)

Tuesday in June and the second (2d) Tuesday in January of each year.

SEC. 2. All writs, process, orders, continuances, appeals, bonds, recognizances, notices and proceedings issued, made or returnable to the general terms of court in and for said counties respectively, as prescribed by law prior to the passage of this act, shall be deemed and construed as made, taken and returnable to the proper term of said court, in the said counties respectively, as prescribed in this act.

SEC. 3. All acts and parts of acts inconsistent with this act are hereby repealed.

SEC. 4. This act shall take effect and be in force from and after its passage.

## CHAPTER 141.

Fourteenth judicial district. AN ACT TO FIX THE TIMES FOR HOLDING THE GENERAL TERMS OF DISTRICT COURT IN AND FOR NORMAN COUN-TY, IN THE FOURTEENTH (14TH) JUDICIAL DISTRICT, MINNESOTA.

Be it enacted by the Legislature of the State of Minnesota:

Terms of court. SECTION 1. That the general term of the district court in and for the county of Norman, Fourteenth (14th) judicial district of the state of Minnesota, shall be held in each year on the first (1st) Wednesday after the first (1st) Monday of November; *Provided*, That the judge of said court and county commissioners of said courty may, by order made and filed with the clerk of said court at least forty (40) days prior to the first (1st) Monday of May in each year, convene said court in general term on said first (1st) Monday of May in each year.
