AN ACT TO AMEND SECTION FOUR HUNDRED AND TWELVE (412) OF TITLE EIGHT (8) OF CHAPTER THIRTY-FOUR (34) OF THE GENERAL STATUTES OF THE STATE OF MINNESOTA OF ONE THOUSAND EIGHT HUNDRED AND SEVENTY-EIGHT (1878), RELATING TO CORPORATIONS.

Be it enacted by the Legislature of the State of Minnesota :

SECTION 1. That section four hundred and twelve (412) of title eight (8) of Chapter thirty-four (34) of the General Statutes of the state of Minnesota of one thousand eight hundred and seventy-eight (1878), relating to corporations, be and the same hereby is amended by adding the following to said section, to-wit:

Incorporations
may provide for
special, pre-
ferred and com-
mon stock.

"*Provided*, That any corporation may, by its articles of incorporation or by any amended article of its articles of incorporation, provide for special, preferred and common stock, or special or preferred and common stock, of the capital stock of such corporation; and any corporation heretofore or hereafter organized without changing its articles of incorporation may issue its capital stock as a part special and a part preferred and a part common, or a part common and a part either special or preferred, by direction of its board of directors, when so authorized by a majority of its stockholders at its annual meeting or at a meeting called for that purpose; and said board of directors, when so authorized by said meeting of said stockholders, may give such preference as it may deem best to such special or preferred stock, or such special and preferred stock."

SEC. 2. This act shall take effect and be in force on and after its passage.

AN ACT TO AMEND SECTION ONE HUNDRED AND THIRTY-FOUR (134) OF CHAPTER THIRTY-SIX (36) OF THE GENERAL STATUTES OF EIGHTEEN HUNDRED AND SEVENTY-EIGHT (1878), RELATING TO STATE NORMAL SCHOOLS.

Be it enacted by the Legislature of the State of Minnesota :

SECTION 1. That section number one hundred and thirty-four (134) of Chapter thirty-six (36) of the General Statutes of eighteen hundred and seventy-eight (1878) be and

the same is hereby amended by inserting after the words "normal department," in the fourth line, the following: "The diploma from either the elementary or advanced course of study of the state normal school shall be valid as a certificate of qualification of the first (1st) grade to teach in the public schools of the state of Minnesota for a period covering the time of the student's pledge of service, namely, two (2) years from date of graduation."

Normal board diploma valid as first grade certificate for two years.

SEC. 2. At the expiration of two (2) years of actual teaching service the diploma of such graduate may be endorsed by the president of the normal school from which it was issued, and by the state superintendent of public instruction, upon satisfactory evidence that such service has been successful and satisfactory to the supervising school authorities under whom it has been rendered. Such endorsement shall make the diploma of the elementary course a valid certificate for five (5) years from its date, and the diploma of the advanced course a permanent certificate of qualification.

Endorsement on elementary diploma at end of two years to be valid certificate for five years.

Endorsement on advance course diploma to be a permanent certificate.

SEC. 3. Any county or city superintendent of schools under whose supervision such graduates may be employed shall have authority to suspend such certificate for causes duly shown, such suspension to be subject to the same appeal as is provided in the case of certificates issued by such county or city superintendents.

Certificates may be suspended for cause.

SEC. 4. This act shall take effect and be in force from and after its passage.

CHAPTER 73.

AN ACT TO AMEND SECTION SIXTEEN (16) OF CHAPTER THIRTY-SIX (36) OF THE GENERAL STATUTES OF ONE THOUSAND EIGHT HUNDRED AND SEVENTY-EIGHT (1878), RELATING TO THE ORGANIZATION OF SCHOOL DISTRICTS.

General Statutes 1878, amending Chap. 36, Sec. 16.

Be it enacted by the Legislature of the State of Minnesota :

SECTION 1. That section sixteen (16) of Chapter thirty-six (36) of the General Statutes of Minnesota of one thousand eight hundred and seventy-eight (1878) be and the same is hereby amended by adding to the end of said section the following: "Provided, Fifth, that whenever the boundaries of any school district are changed, or any school district is divided, said commissioners shall make a division of all moneys, funds and credits belonging to such district, and shall make an award of such moneys,

When school districts are divided, moneys, funds and credits are also to be divided.
