

## CHAPTER 359.

S. F. No. 11.

*An act to appropriate twenty thousand (\$20,000) dollars to aid the sufferers by forest fires during the summer of 1894 in Pine county and adjacent counties of the state of Minnesota.*

Forest fire sufferers.

Be it enacted by the Legislature of the state of Minnesota:

SECTION 1. That the sum of twenty thousand dollars (\$20,000) is hereby appropriated out of any funds of the state treasury not otherwise appropriated to aid the sufferers by fire in Pine county and adjacent counties occasioned by the burning of the forests in said counties during the summer of eighteen hundred and ninety-four, the amount appropriated to be expended under the direction of the Minnesota state commission for relief of fire sufferers.

Appropriation.

SEC. 2. The state auditor is hereby authorized to draw his warrant for the sum appropriated hereby, upon the state treasurer of the state of Minnesota in favor of the chairman of the Minnesota state commission for relief of fire sufferers.

How paid out.

SEC. 3. This act shall take effect and be in force from and after its passage.

## CHAPTER 360.

S. F. No. 514.

*An act to provide for the erection and maintenance of a hard fiber twine plant at the state prison at Stillwater, Minnesota.*

State prison.

Be it enacted by the Legislature of the state of Minnesota:

SECTION 1. The warden of the state prison is hereby empowered by and with the advice and approval of the board of managers of the state prison, at cost not exceeding twenty-five thousand (\$25,000) dollars to purchase, erect and maintain the necessary machinery and equipments for the manufacture of twines known as hard fiber twine.

Hard fiber twine industry.

SEC. 2. For the purpose of purchasing and erecting the necessary machinery required to be purchased, erected and used under this act, the warden of the state prison by and with the advice and approval of the "board of managers" is empowered to expend the sum

of fifteen thousand six hundred and eighty-three (\$15,683) dollars remaining in the state treasury and unexpended out of the amount heretofore appropriated for the purchase of a twine plant, and there is hereby also appropriated for the same purpose the sum of nine thousand (\$9,000) dollars out of any money in the state treasury not otherwise appropriated or so much thereof as may be necessary.

SEC. 3. This act shall take effect and be in force from and after its passage.

CHAPTER 361.

S. F. No. 411.

Institute for  
defectives.

*An act to appropriate money for certain purposes to the Minnesota Institute for Defectives.*

Be it enacted by the Legislature of the state of Minnesota:

Appropriation.

SECTION 1. That the sum of three thousand five hundred dollars (\$3,500) be and the same is hereby appropriated out of any moneys in the state treasury not otherwise appropriated for the purpose of completing and furnishing a school building in process of erection on the grounds of the school for the feeble-minded at the city of Faribault in this state.

Three thousand dollars (\$3,000) of the moneys so appropriated shall be employed in completing the construction of the said building, and the remainder thereof shall be employed in furnishing the same when completed for the use of the said school.

How paid.

SEC. 2. The moneys hereby appropriated shall be and become immediately available upon the passage of this act for the purposes provided in section one thereof, and the state auditor is authorized to draw his warrants for the payment of the same in favor of the person or persons indicated by the order or orders of the board of directors of the said institute.

SEC. 3. This act shall take effect and be in force from and after its passage.
