CHAPTER 371.

Detaching
Renville Co.
from 9th
judicial dist.

An act to detach Renville county, Minnesota, from the Ninth judicial district, and attaching that for judicial purposes to the Twelfth judicial district and fixing the time of holding court therein.

Be it enacted by the Legislature of the state of Minnesota:

SECTION 1. That the county of Renville, in the state of Minnesota, be detached from the Ninth judicial district, and that Renville county, be and the same is hereby attached to and made a part of the Twelfth judicial district.

SEC. 2. That the general terms of court in and for the county of Renville be held on the second Tuesday in May, and the third Tuesday in November of each year.

SEC. 3. All acts and parts of acts inconsistent with this act are hereby repealed.

SEC. 4. This act shall take effect and be in force from and after its passage.

CHAPTER 372.

Court terms,
13th dist.

An act to amend chapter three hundred and fourteen (314) of the general laws of 1895, entitled "An act fixing the general terms of the district court in the several counties of the 13th judicial district.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the last paragraph of section one (1) of chapter three hundred and fourteen (314) of the general laws of 1895, be and the same is hereby amended so as to read as follows:

"In Cottonwood county on the first Monday in June, and the third Monday in November of each year."

SEC. 2. That all writs, processes, recognizances, appeals, notices and proceedings had, issued or returnable for the terms of court in and for said county as fixed prior to the passage of this act shall be deemed and construed as made, taken and returnable to the proper term of court in said county as fixed by this act.

SEC. 3. All acts and parts of acts inconsistent with this act are hereby repealed.

SEC. 4. This act shall take effect and be in force from and after its passage.

CHAPTER 373.

H. F. No. 1019.

An act fixing the time for holding the general terms of the district court in Murray and Pipestone counties.

Court terms,
Murray and
Pipestone
Co's.

Be it enacted by the Legislature of the state of Minnesota.

SECTION 1. That section one (1) of chapter three hundred and fourteen (314) of the general laws of eighteen hundred and ninety-five (1895) be amended by striking out the third and fourth subdivisions thereof and inserting in lieu thereof the following:

"In Murray county the first (1st) Tuesday in May and December of each year.

"In Pipestone county the third (3rd) Tuesday in May and December in each year."

SEC. 2. All acts and parts of acts inconsistent with this act are hereby repealed.

SEC. 3. This act shall take effect and be in force from and after the first (1st) day of June, one thousand eight hundred and ninety-seven (1897).

CHAPTER 374.

H. F. No. 658.

An act to include the county of Red Lake in the Fourteenth (14th) judicial district, and to fix the time for holding the general terms in the district court therein.

Placing Red
Lake Co. in
14th judicial
dist.

Be it enacted by the Legislature of the state of Minnesota:

SECTION 1. That the county of Red Lake shall be and the same is hereby constituted a part of the Fourteenth (14th) judicial district.

SEC. 2. That the general terms of the district court, in the county of Red Lake, in the fourteenth (14th) judicial district of the state of Minnesota, shall be held on the
