

CHAPTER 366.

An act fixing the regular terms of the district court in the Fifteenth (15th) judicial district.

Fifteenth judicial district, terms of court in.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. The regular terms of the district court in the following organized counties constituting the Fifteenth (15th) judicial district shall be held as follows:

In Crow Wing county on the first (1st) Tuesday in March and on the first (1st) Tuesday in September in each year.

Crow Wing county, terms of court in.

In Cass county on the first Tuesday in May of each year.

Cass county, terms of court in.

In Beltrami county on the first (1st) Tuesday in November of the year one thousand eight hundred and ninety-nine (1899), and thereafter on the first (1st) Thursday in November of each and every year.

Beltrami county, terms of court in.

In Hubbard county on the first (1st) Tuesday of July of each year.

Hubbard county, terms of court in.

In Itasca county on the first (1st) Tuesday in January and on the first (1st) Tuesday in June of each year.

Itasca county, terms of court in.

In Aitkin county on the first (1st) Tuesday in October of each year.

Aitkin county, terms of court in.

In Wadena county on the first (1st) Tuesday in December of each year.

Wadena county, terms of court in.

SEC. 2. This act shall take effect and be in force from and after its passage and approval.

CHAPTER 367.

S. F. No. 123.

An act fixing the time for holding the general terms of the district court in the Fourteenth judicial district.

Fourteenth judicial district, terms of court in.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. The general terms of the district court in and for the Fourteenth judicial district of the State of Minnesota shall be held as follows:

In the county of Norman on the fourth Monday in November and the second Monday in July of each year.

Norman county, terms of court in.

In the county of Polk on the second Tuesday in December and the first Tuesday in June of each year.

Polk county, terms of court in.

Red Lake
county, terms
of court in.

In the county of Red Lake on the second Monday in February and on the fourth Monday in October of each year.

Marshall
county, terms
of court in.

In the county of Marshall on the second Tuesday of November and the second Tuesday of March of each year.

In the county of Kittson on the fourth Monday in February of each year.

Roseau
county, terms
of court in.

In the county of Roseau on the second Monday in May of each year.

SEC. 2. All acts or parts of acts inconsistent with the provisions of this act are hereby repealed.

SEC. 3. This act shall take effect and be in force from and after its passage.

CHAPTER 368.

Fifteenth and
Seventh ju-
dicial dis-
tricts, Wadena
county.

An act to detach Wadena county of the Fifteenth (15th) judicial district and attach the same to the Seventh (7th) judicial district.

Be it enacted by the Legislature of the State of Minnesota:

Wadena
county, de-
tached from
Fifteenth and
attached to
Seventh dis-
trict.

SECTION 1. That the county of Wadena be and the same is hereby detached from the Fifteenth (15th) judicial district and attached to and shall hereafter constitute a part of the Seventh (7th) judicial district of this state.

Terms of
court in.

SEC. 2. The regular terms of the district court in said county of Wadena shall be held on the first (1st) Monday in June and the second (2nd) Monday in December of each year, and all writs, recognizances and other process, orders or matters of the district court of said county now returnable at any other date shall be returnable on the first (1st) Monday of June, eighteen hundred and ninety-nine (1899), fixed by this act as the day for the regular term of said court next ensuing after the passage of this act.

SEC. 3. This act shall take effect and be in force from and after its passage.
